I. Introduction

1. On 5 May 2017, Mr Karim Khan, a lawyer on the List of Counsel at the International Criminal Court, was appointed as Counsel for Mr Saif Al-Islam Gaddafi ("Mr Gaddafi"). Upon Mr Khan's request, Ms Shyamala Alagendra was appointed as Associate Counsel for Mr Saif Al-Islam Gaddafi ("Mr Gaddafi") on 12 May 2017.

II. Classification

2. In accordance with regulation 23 bis(1) of the Regulations of the Court "RoC", annex I to the present submission is classified as *ex parte* Registry and Defence only because it refers to the attorney-client relationship.

III. Applicable Law

3. This submission is made on the basis of articles 43 and 67(1)(d) of the Rome Statute, rules 20 to 22 of the Rules of Procedure and Evidence, regulation 67 of the RoC, regulation 123(1) of the Regulations of the Registry, articles 5, 7(4) and 22(3) of the Code of Professional Conduct for counsel ("Code").¹

IV. Submission

4. The Registry informs the Chamber that the defence team for Mr Gaddafi currently composed as follows:
