Pre-Trial Chamber II (“Chamber”) of the International Criminal Court (“Court”), acting under article 87(7) of the Rome Statute, issues this decision requesting the Hashemite Kingdom of Jordan (“Jordan”) to provide further information.

1. The Chamber is currently seized, under article 87(7) of the Statute, of the question whether Jordan failed to comply with the Court’s request for arrest and surrender of Omar Hassan Ahmad Al-Bashir (“Omar Al-Bashir”) contrary to the provisions of the Statute when Omar Al-Bashir was present on Jordan’s territory on 29 March 2017, thereby preventing the Court from exercising its functions and powers under the Statute.¹
2. On 30 June 2017, the Registry transmitted to the Chamber a note verbale containing Jordan’s submissions in relation to the pending matter.²
3. On 13 July 2017, the Prosecutor responded to Jordan’s submissions.³
4. Jordan’s submissions to the Chamber include the argument that Omar Al-Bashir “enjoyed immunity from criminal jurisdiction of Jordan during his attendance of the Arab Summit as a matter of treaty law pursuant to the 1953 Convention on the Privileges and Immunities of the Arab League (acceded to by Jordan on 12 December 1953)”.⁴
5. However, the Chamber has not been provided with the text of this convention. Moreover, it appears that the convention has not been registered with the Secretariat of the United Nations and published by it, in line with article 102(1) of the Charter of the United Nations. The Chamber notes that the convention has been published in

English as part of the United Nations Legislative Series in 1961,⁵ but does not consider it possible to determine the issues under consideration based on information which is not authoritative.

6. In order to be placed in position to properly consider Jordan's submissions, the Chamber considers it appropriate to request Jordan to complement its submissions by providing to the Chamber an authoritative text of the 1953 Convention on the Privileges and Immunities of the Arab League as well as the status of its ratification. Jordan may also elaborate its submissions as concerns the alleged treaty-based immunity of Omar Al-Bashir.

FOR THESE REASONS, THE CHAMBER HEREBY

REQUESTS the Hashemite Kingdom of Jordan to provide the Chamber with an authoritative text of the 1953 Convention on the Privileges and Immunities of the Arab League as well as the status of its ratification, by 18 October 2017.
