PRE-TRIAL CHAMBER III (the "Chamber") of the International Criminal

Court (the "Court") issues this decision concerning the election of the

Presiding Judge of the Chamber in the situation in the Islamic Republic of

Afghanistan ("Afghanistan").

1. On 30 October 2017, the Prosecutor informed the Presidency of her

decision to request judicial authorisation to commence an investigation into

the situation in Afghanistan pursuant to regulation 45 of the Regulations of

the Court ("Regulations").1

2. On 3 November 2017, the Presidency decided "to assign, with

immediate effect, the situation in the Islamic Republic of Afghanistan to Pre-

Trial Chamber III".2

3. The Chamber notes regulation 13(2) of the Regulations pursuant to

which the Judges of each Pre-Trial Chamber shall elect from amongst their

members a Presiding Judge.

4. On 7 November 2017, the Judges of the Chamber decided to elect a

Presiding Judge for each situation assigned to the Chamber. In addition, the

Judges of the Chamber decided that Judge Antoine Kesia-Mbe Mindua will

act as the Presiding Judge of the Chamber in the situation in Afghanistan with

immediate effect.
