I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 11 August 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Pre-Trial INCRIM package 083” containing 242 items, “Pre-Trial INCRIM package 084” containing 1 item, “Pre-Trial Rule 77 package 050” containing 224 items and “Pre-Trial Rule 77 package 051” containing 11 items.

4. The disclosure of “Pre-Trial INCRIM package 083” consists of the re-disclosure of items previously disclosed, now with lesser redactions.

5. The disclosure of “Pre-Trial INCRIM package 084” includes the English translation of a previously disclosed statement.¹

6. The disclosure of “Pre-Trial Rule 77 package 050” consists of items that are deemed material to the preparation of the Defence that are now re-disclosed with lesser redactions.

7. The disclosure of “Pre-Trial Rule 77 package 051” consists of items that are deemed material to the preparation of the Defence. It includes telecommunications reports and call sequence tables (CST) related to the review of call data records and

other telecommunications of Witnesses P-0338, P-0787, P-0834, P-1167, P-2105, P-2161, P-3064 and P-2563.
