## I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

### III. SUBMISSIONS

- 3. On 12 October 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Trial INCRIM package 090" containing 16 items, "Trial reclassification to INCRIM package 008' containing 2 items, "Trial Rule 77 package 060" containing 48 items and "Trial reclassification to Rule 77 package 003" containing 4 items.
- 4. The disclosure of "Pre-Trial INCRIM package 090" consists of the re-disclosure of lesser redacted versions of three statements, annexes and its corresponding translations related to P-3053, P-3056 and P-3064 pursuant to the Trial Chamber's Decision on 10 October 2022¹ and two items re-disclosed with lesser redactions relevant to P-0338.
- 5. The disclosure of "Trial reclassification to INCRIM package 008" contains one translation and one transcript being reclassified as INCRIM and related to P-1339 as both form part of his in-court testimony in the *Yekatom and Ngaissona* case.
- 6. The disclosure of "Pre-Trial Rule 77 package 060" consists of items that are deemed material to the preparation of the Defence. It contains 10 audio/video items and associated materials relevant to P-1339, Call Data Reports and associated material of 5 trial witnesses P-1808, P-0966, P-2087, P-1263 and P-2263; one item relevant to P-

2105, one item shown to P-1167 during his interview; and three items relevant to P-3056's witness preparation.

7. The disclosure of "Trial reclassification to Rule 77 package 003" consists of 2 audio/video and associated material reclassified as Rule 77 and relevant to P-1339.
