I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 25 October 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 092” containing 25 items, “Trial reclassification to INCRIM package 010” containing 3 items, and “Trial Rule 77 package 063” containing 12 items.

4. The disclosure of “Trial INCRIM package 092” consists of the re-disclosure of lesser redacted versions of P-0885 witness statement and its translation, of an investigation report related to P-2105, of Annex D to witness P-0787 statement, and of 21 other items relevant to P-3108 following a request by the Defence.

5. The disclosure of “Trial reclassification to INCRIM package 010” contains the un-redacted versions of Mr Said’s Call Data Records, Telecommunications report and its annex.

6. The disclosure of “Trial Rule 77 package 063” consists of items that are deemed material to the preparation of the Defence. It contains the witness preparation logs and annexes related to P-2105 and P-3108, three audio/ video materials, an

investigation report on additional disclosable information related to P-2105,¹ and the FSS report on the extraction of data from the mobile phone and sim card related to P-0349.
