## I. Introduction

1. The Registry hereby submits with the present report and its 21 annexes, the public redacted and confidential versions of email decisions ("Quarterly Report") pursuant to the "Third decision on matters related to the conduct of proceedings" ("Third Decision"), issued on 4 September 2020 by Trial Chamber X ("Chamber").

# II. Procedural History

- 2. On 4 September 2020, the Chamber issued the Third Decision in which it stated that: "[...] to expedite decisions on minor procedural matters or in order to react to urgent circumstances, occasional rulings from the Chamber and the Single Judge have been issued by way of email sent to the parties and participants. In order to ensure that the principles of fairness and publicity are respected, the Chamber finds it appropriate to adopt a system whereby these email decisions are systematically put on the record of the case."<sup>2</sup>
- 3. The Chamber further directed the Registry to file all email decisions on the case record in Quarterly Reports starting on 1 October 2020<sup>3</sup> and provided criteria for the application of redactions to these email decisions.<sup>4</sup>
- 4. The Chamber also clarified in the Third Decision that emails related to the submission of evidence should not be part of the Quarterly Reports as these emails are put on the record by way of a separate procedure.<sup>5</sup>

### III. Level of classification

5. Pursuant to regulation 23bis(1) of the Regulations of the Court, the present submission and its Annexes 1 to 3, 5 to 9 and 11 to 21 are classified as "confidential" whereas Annexes 4 and 10 are classified as "confidential *ex parte*" because they refer to sensitive information that should not be disclosed to the public.

# IV. Applicable Law

6. For the purpose of the present submission, the Registry has considered articles 64(7), (10) and 67(1) of the Rome Statute and rule 140 of the Rules of Procedure and Evidence.

#### V. Submission

- 7. On 18 January 2021, the Chamber instructed the Registry to file Quarterly Reports of the unredacted email decisions, with their original classification, and consult in due course the parties and participants with regard to public redacted versions.<sup>6</sup>
- 8. On 19 August 2022, the Defence for Mr. Al Hassan ("Defence") proposed additional redactions to be applied in Annex 13.7
- 9. On the same day, the Defence and the Registry Detention Section jointly requested that Annex 10 maintains its level of classification, *EX PARTE* only available to the Defence and the Detention Section.<sup>8</sup>

- 10. On 2 September 2022, the Chamber instructed the Registry to apply redactions proposed by the Defence in Annex 13 and instructed the Registry to maintain the level of classification of Annex 10 as confidential *EX PARTE* only available to the Defence and the Registry Detention Section.<sup>9</sup>
