**Judge Raul C. Pangalangan**, acting as Single Judge on behalf of Trial Chamber VIII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court ('Court') issues the following 'Decision on Prosecution Requests for Authorisation to Disclose Anonymous Summaries', in the case of *The Prosecutor v. Ahmad Al Faqi Al Mahdi*, having regard to Article 64(2) of the Rome Statute.

- 1. On 30 June 2016, the Office of the Prosecutor ('Prosecution') filed a request seeking authorisation to disclose anonymous summaries of P-523's interview and of P-140's screening notes. On 14 July 2016, the Prosecution filed an addendum to the request.
- 2. On 1 July 2016, the Prosecution filed a request seeking authorisation to disclose an anonymous summary of P-357's screening notes.<sup>3</sup>
- 3. On 6 July 2016, the Single Judge shortened the deadline for response to 18 July 2016.<sup>4</sup>
- 4. Neither the defence team for Mr Al Mahdi ('Defence') nor the Legal Representative of Victims responded to the requests.
- 5. The Single Judge notes that the requests are unopposed and therefore grants them on this basis. Accordingly, the Prosecution shall disclose forthwith the anonymous summaries proposed in annexes B and E to ICC-01/12-01/15-116-Conf-Exp and in annex A to ICC-01/12-01/15-123-Conf-Exp.
