TRIAL CHAMBER VIII of the International Criminal Court hereby issues this 'Decision Notifying the Election of a Presiding Judge' in the case of *The Prosecutor v. Ahmad Al Faqi Al Mahdi*, having regard to Regulation 13(2) of the Regulations of the Court.

- In May 2016, the Presidency of the Court constituted Trial Chamber VIII, composed of Judges Antoine Kesia-Mbe Mindua, Bertram Schmitt and Raul C. Pangalangan, and referred to it the current case.¹ The Chamber then elected Judge Raul C. Pangalangan as Presiding Judge and Single Judge.²
- 2. On 16 March 2021, the Presidency of the Court re-constituted the Chamber, assigning to it Judge María del Socorro Flores Liera, to replace Judge Raul C. Pangalangan.³
- On 26 March 2021, the Judges of the Chamber decided that Judge Antoine Kesia-Mbe Mindua is the Presiding Judge of the Chamber with immediate effect.

FOR THE FOREGOING REASONS, THE CHAMBER HEREBY

DESIGNATES Judge Antoine Kesia-Mbe Mindua as Presiding Judge of Trial Chamber VIII.
