#### I. Introduction

- 1. On 28 March 2023, Pre-Trial Chamber II ("Chamber") issued its "Decision on the legal representation of victims" in *The Prosecutor v. Maxime Jeoffroy Eli Mokom Gawaka* ("Mokom case" or "Case"), ordering the Registry to *inter alia* liaise with Ms Massidda, Mr Tendouli and Mr Kassongo with a view to consulting the persons seeking to have them appointed ("Concerned Persons") as to whether they wish to be represented by the team of common legal representatives appointed by the Chamber for the purposes of the present proceedings, and to report on this matter by no later than 31 May 2023 ("Decision").<sup>1</sup>
- The Registry hereby submits its report on the consultations of the Concerned Persons ("Report").

#### II. Classification

3. Pursuant to regulation 23bis(1) of the Regulations of the Court ("RoC") the annex to the present submission is classified as confidential *ex parte*, only available to the Registry, as it contains identifying information on a person acting on behalf of Concerned Persons.

#### III. Submissions

4. The Registry's Victims Participation and Reparations Section ("VPRS") informs that 137 Concerned Persons were consulted pursuant to the Decision, as follows: 71 Concerned Persons consulted through Ms Massidda from the

Office of Public Counsel for Victims ("OPCV"); 11 through Mr Kassongo; and 55 initially through Mr Tendouli and subsequently through another person acting on their behalf ("Person Acting on Behalf of 55 Concerned Persons").<sup>2</sup>

- 5. The said consultation provided the following information to the Registry :
  - Ms Massidda indicated that the aforementioned 71 persons were informed of the Decision and that, "while indicating that they would have preferred that we continue the legal representation, victims do not have substantive objections to being represented by the team of lawyers designated by the Pre-Trial Chamber";<sup>3</sup>
  - Mr Kassongo indicated, as to the above-mentioned 11 Concerned Persons, that they are considering to not participate at this preliminary stage of the current proceedings, as "they have doubts on their participation at the stage of the confirmation hearing"; he instructed the VPRS to "thus put aside these victim applications for the present stage of the proceedings";<sup>4</sup> and
  - Mr Tendouli reported with respect to the aforesaid 55 persons that "they do not wish to be represented by any other lawyer than him. Consequently, they will not continue with the *Mokom* proceedings".<sup>5</sup> Between 28 April and 16 May 2023, the VPRS received the following information from the Person Acting on Behalf of 55 Concerned Persons:

that they now expressed their wish: (i) to continue with their request for participation to the *Mokom* case,<sup>6</sup> and; (ii) to be represented by the team of common legal representatives of victims appointed for the purpose of the present proceedings, if their status of participating victims in the *Mokum* case is established by the Chamber.<sup>7</sup>

6. Based on the information and supporting document received at present,<sup>8</sup> the Registry is of the view that the information provided by the Person Acting on Behalf of 55 Concerned Persons provides sufficient proof these persons' current wish as outlined above.<sup>9</sup>

#### IV. Conclusion

7. Based on the information received following VPRS's consultations pursuant to the Decision, the Concerned Persons as regard Maîtres Massidda and Tendouli respectively as above, wish to continue their participation in the present proceedings through the team of common legal representatives appointed by

the Chamber. As to the 11 Concerned Persons as regard Mr Kassongo as above, they are considering to not participate in the present stage of proceedings.<sup>10</sup>
