I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) requests Trial Chamber V (“Chamber”) to recognise as formally submitted [REDACTED] items of evidence obtained from, or related to [REDACTED] Facebook [REDACTED] (“Facebook Evidence”).¹ The Request is made pursuant to the Chamber’s invitation to submit evidence in writing through a ‘bar table’ application,² and in accordance with articles 64(9)(a), 69(3), and 69(2), (3), and (4).
2. The Facebook Evidence is relevant to material issues at trial, is mutually corroborative, and bears sufficient indicia of reliability. As demonstrated in this application and its Annex, each item of evidence satisfies *prima facie* the criteria for submission.
3. Recognising the formal submission of the Facebook Evidence at this stage of the trial causes no undue prejudice. It will enable the Chamber to make use of it during the trial, understand other evidence in the case, and ultimately assist in determining the truth. Recognising the formal submission of the Facebook Evidence will also contribute to an expeditious trial.
4. As requested by the Chamber, the Annex to this filing details for each of the [REDACTED] items of evidence: (i) the evidence registration number (“ERN”); (ii) the type;³ (iii) the title;⁴ (iv) the main date of the document;⁵ (v) a short description of the item; (vi) its relevance and probative value; and (vii) the date of disclosure.⁶ All of these items were included on the Prosecution’s 9 November 2020 List of Evidence, as indicated below.

II. CONFIDENTIALITY

5. Pursuant to regulation 23bis(1) of the Regulations of the Court (“RoC”), the Prosecution files this Request as ‘*Confidential*’ because it contains confidential information. A public redacted version will be filed as soon as practicable.

III. SUBMISSIONS

6. The Facebook Evidence meets the criteria for the recognition of its formal submission, in accordance with the Chamber’s “Decision on the First Prosecution Submission Request from the Bar Table (Sexual and Gender Based Violence)”.⁷
7. The Facebook Evidence is relevant to the issues at trial, has significant probative value, and does not unfairly prejudice the Accused. The relevance and probative value of the ten Facebook accounts is discussed in turn below.
8. Per the Initial Directions,⁸ on 17 March 2023, the Prosecution inquired with the Defence whether they consent or object to the items in the Annex. Notably, both Defence teams indicated that they would not provide an answer within the eight weeks deadline proposed by the Prosecution, foreseen initially on 28 April 2023 and extended to 11 May 2023. In light of these circumstances, the Prosecution files the present Request.

A. Background

9. The Facebook Evidence comprises [REDACTED] conversations and related meta-data, as well as the relevant Request for Assistance (“RFA”) and response [REDACTED].
10. The conversations and related meta-data were obtained [REDACTED], pursuant to an RFA⁹ [REDACTED], and transmitted them to the Prosecution in January 2019.¹⁰

B. The Facebook Evidence is relevant to the issues at trial

11. The Facebook Evidence is relevant to the case and would assist the Chamber to determine the truth.¹¹ It is particularly relevant to NGAISSONA’s individual criminal responsibility, as its content bears on NGAISSONA’s contributions as set out in the Decision on the Confirmation of Charges: (i) taking steps to structure the Anti-Balaka; (ii) financing the Anti-

Balaka; (iii) issuing instructions to Anti-Balaka members; and (iv) liaising with Anti-Balaka members exercising key functions.¹²

12. The Facebook Evidence comprises the [REDACTED]. In describing their relevance below, the Prosecution provides a summary translation and/or interpretation of the underlying conversation excerpts in each Footnote.

14. Open source information from 2012-2013 already shows that YAKETE was close to President François BOZIZE (“BOZIZE”). In particular, it shows that: (i) in December 2012, he created the *Coalition Citoyenne d’Opposition aux Rebelions Armées* (“COCORA”) to counter the Seleka’s descent to BANGUI and in support of BOZIZE;¹⁶ (ii) in 2013, he acted as BOZIZE’s spokesperson;¹⁷ and (iii) in August 2013, his movement *Mouvement Révolutionnaire Populaire pour la libération* (“MOREPOL”) adhered to BOZIZE’s movement *Front pour la Restauration de l’Ordre Constitutionnel en Centrafrique* (“FROCCA”).¹⁸

15. These Facebook conversations are highly relevant, in particular with respect to BOZIZE's inner circle, Anti-Balaka activities on the ground, and NGAISSONA's intent and knowledge regarding their crimes.

16. *First*, the Facebook conversations demonstrate that YAKETE was associated with the Anti-Balaka,¹⁹ and that he was in [REDACTED],²⁰ [REDACTED],²¹ [REDACTED].²² He was also [REDACTED].²³

17. *Second*, they show that YAKETE, as a founding member of FROCCA,²⁴ was a key figure in the organisation of the Anti-Balaka, and their plan to overthrow DJOTODIA and the Seleka regime.²⁵ They show for example, that he developed strategies to motivate the Anti-Balaka on the ground, in preparation of the 5 December 2013 attack on BANGUI;²⁶ that he was involved in the provision of ammunition prior the 5 December 2013 attack on BANGUI;²⁷ that he had regular contact with the Anti-Balaka stationed in different areas;²⁸ and that he was going to visit them at the CAMEROONIAN border.²⁹ They also show that YAKETE claimed the Anti-Balaka attacks on BOSSANGOA in September 2013,³⁰ and on BANGUI on 5 December 2013.³¹

18. *Finally*, the conversations confirm NGAISSONA's role and position in the Anti-Balaka movement. They demonstrate, *inter alia*, his close relationship to Bernard MOKOM;³² his

coordination of military actions together with Bernard MOKOM;³³ the financing of the elements' transportation to the field;³⁴ the communication of information to the field, such as the position of the enemy;³⁵ NGAISSONA's presence in FRANCE in August 2013,³⁶ NGAISSONA's involvement in FROCCA's strategic meetings;³⁷ his direct involvement in the BOUAR military operations;³⁸ his invitation to the NDJAMENA talks on 9 January 2014 as one of the key Anti-Balaka leaders;³⁹ his arrival in BANGUI on 14 January 2014 upon BOZIZE's request;⁴⁰ and his actions as the Anti-Balaka National General Coordinator, including concentrating powers in his hands;⁴¹ promoting the Gbaya interest;⁴² proposing individuals to political positions as he saw fit;⁴³ and gathering knowledge about Anti-Balaka disorder and the commission of crimes in the provinces.⁴⁴

24. *Third*, the conversations provide insight into the Anti-Balaka's strategy to regain power,⁶⁷ and in the group's organisation and coordination of attacks on BOSSANGOA (aka "BOSTON") and its surroundings,⁶⁸ on BOUCA⁶⁹ in September 2013, on BOUAR in October 2013,⁷⁰ and on BANGUI and BOSSANGOA on 5 December 2013.⁷¹ They also provide

information on the obtaining of weapons,⁷² and on the positions and movements of Anti-Balaka elements in CAMEROON⁷³ and in ZONGO, DRC.⁷⁴ The conversations also confirm that [REDACTED] was the chief of the archers from BOSSANGOA;⁷⁵ that Bernard MOKOM was coordinating the FACA and archers who attacked BOUAR,⁷⁶ and continued on to BAORO;⁷⁷ that the needs requested from the field through NGAISSONA were met;⁷⁸ and that the anti-Muslim mind-set and thirst for revenge was evident and prevalent within the group.⁷⁹

25. Finally, the conversations confirm NGAISSONA's role and position in the Anti-Balaka movement, and in particular: his presence in CAMEROON⁸⁰ and in FRANCE;⁸¹ his organisation of the manifestation in Boy-Rabe for DJOTODIA's swearing in;⁸² his travel with Bernard MOKOM to BERTOUA and GAROUA-BOULAI to liaise with the archers in BOUAR;⁸³ his contact and meetings with BOZIZE,⁸⁴ Bernard MOKOM, and Maxim MOKOM regarding operations on the ground;⁸⁵ his provision of Thuraya, ammunition, and medicine to the elements in BOUAR⁸⁶ and ZONGO;⁸⁷ the provision of money to the Anti-Balaka elements on the ground;⁸⁸ his organisation of the attack on BOUAR around 26 October 2013;⁸⁹ his sending of elements to the border;⁹⁰ his political aspirations;⁹¹ his 24 November 2013 request to elements in BOUAR to reach BOSSEMELE in three days (*i.e.*, in view of the 5 December

had the ability to impede operations,¹⁴² and who knew about the group's financing.¹⁴³ The conversations further provide insight on: 'the boss' transmitting instructions to the Anti-Balaka on 6 October 2013, through NGAISSONA;¹⁴⁴ NGAISSONA's trips to the Cameroonian border to meet the chief of the archers, trips which would ensure the success of the DAMARA attack;¹⁴⁵ NGAISSONA's instructions to elements on the ground to advance to the Cameroonian border in November 2013,¹⁴⁶ or to BANGUI in preparation for the 5 December 2013 attack;¹⁴⁷ and NGAISSONA's arrival in BANGUI on 14 January 2014 at 'the boss's' instruction.¹⁴⁸

44. *Third*, the conversations show that FROCCA gathered under its umbrella several pre-existing groups, *inter alia*, MOREPOL of YAKETE,¹⁸⁰ *Collectifs des Jeunes Démocrates Centrafricains* (“CJDC”) of Colonel GOUDOS,¹⁸¹ *Convention des Patriotes pour le Salut de Kodro* (“CPSK”) of Mohammed DHAFFANE,¹⁸² *Collectif des Officers Libres* (“COL”) of KOKATE,¹⁸³ *Front democratique du people centrafricain* (“FPDC”) of Abdoulaye MISKINE,¹⁸⁴ as well as LAMAKA’s *Mouvement Patriotique des Jeunes Centrafricains* (“MPJCA”),¹⁸⁵ and that FROCCA organised its military operations and conducted attacks under the name of *Combattants de Libération du Peuple Centrafricain* (“CLPC”).¹⁸⁶ The conversations further show that FROCCA used [REDACTED]¹⁸⁷ to disseminate information

and communiqués¹⁸⁸ and CLPC/Anti-Balaka press releases,¹⁸⁹ to mobilise the non-Muslim Central African population to stand up and take up arms¹⁹⁰ - similar to COCORA's actions earlier in 2013⁻¹⁹¹ in expectation of the Anti-Balaka elements from CAMEROON¹⁹² and ZONGO;¹⁹³ and to organise several marches, [REDACTED]¹⁹⁴ with the (hidden) aim of the return to the constitutional order.¹⁹⁵

45. *Fourth*, and despite [REDACTED],¹⁹⁶ the conversations provide insight into the Anti-Balaka's control of BOSSANGOA and BOUCA in September 2013;¹⁹⁷ their advancement towards BOSSEMBELE;¹⁹⁸ their anti-Muslim animus;¹⁹⁹ operational issues and problems, such as the lack of ammunition;²⁰⁰ and the group's 5 December 2013 BANGUI attack.²⁰¹

48. *First*, they show that [REDACTED]²⁰⁶ [REDACTED],²⁰⁷ [REDACTED],²⁰⁸ [REDACTED].²⁰⁹

49. *Second*, the conversations show the attack by ‘their men’, i.e., the Anti-Balaka²¹⁰ on BOSSANGOA²¹¹ and their subsequent advancement to BOSSEMBELE,²¹² their attacks on BOUAR,²¹³ and on DAMARA,²¹⁴ and operational information regarding the Anti-Balaka, *inter alia*, the liaising with elements in the field on behalf of Maxime MOKOM.²¹⁵

C. The Facebook Evidence is reliable and authentic

50. The Facebook Evidence is reliable and authentic. To assess *prima facie* reliability of evidentiary material, the Chamber may evaluate the factors affecting its authenticity, such as: its origin, the context in which it was created, the method with which the information contained therein was compiled, and the availability of corroborative evidence.²¹⁶

51. The collection of Facebook Evidence as a whole is self-authenticating. The compilation and maintenance of accurate and complete records is undertaken in the regular course of business and in accordance with domestic laws. The Facebook Evidence was obtained from an objective primary source, [REDACTED], pursuant to a RFA to the competent authorities [REDACTED] sent in 2018,²¹⁷ which the Prosecution also now moves to submit. [REDACTED].²¹⁸

52. Further, the [REDACTED], provide further indicia of reliability and authenticity.

53. Finally, there is corroboration for the information described above in the form of other Facebook Evidence, witness evidence, CDR, and email.

D. The probative value of the Facebook Evidence outweighs any prejudicial effect

54. The submission of the Facebook Evidence does not cause any undue prejudice to the Accused. Besides having used information from these records in the course of the trial themselves, including seeking their formal submission, the Defence will continue to have the opportunity to address the relevance and probative value of such evidence.

55. Further, the Defence is already on notice as to which parts of the Facebook materials are of particular importance to the Prosecution's allegations, given the Prosecution's Trial Brief,²¹⁹ as well as the present Motion.

IV. RELIEF SOUGHT

56. For the above reasons, the Prosecution requests the Chamber to recognise the formal submission of the Facebook Evidence listed in the confidential Annex to this filing.
