## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 14 July 2023, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 118” containing 4 items, “Trial INCRIM package 119” containing 3 items, “Trial Rule 77 package 086” containing 2 items, and “Trial Rule 77 package 087” containing 3 items.

4. Trial INCRIM package 118 consists of lesser redacted version of documents related to Witness P-1762 being re-disclosed and a read back log for Witness P-1424’s certification pursuant to rule 68(2)(b) of the Rules of Procedure and Evidence.

5. Trial INCRIM package 119 consists of lesser redacted versions of documents related to Witness P-3064 being re-disclosed unredacted.

6. Trial Rule 77 package 086 consists of disclosure reports on additional information on Witnesses P-1743 and P-2504.
