TRIAL CHAMBER VI of the International Criminal Court, in the case of *The Prosecutor v. Mahamat Said Abdel Kani*, having regard to articles 64(2) and 67(1) of the Rome Statute (the 'Statute'), rule 135 of the Rules of Procedure and Evidence (the 'Rules'), regulation 92 of the Regulations of the Court and regulations 156 and 189 of the Regulations of the Registry, issues this 'Decision Concerning Access of Experts to Mr Said's Medical Records'.

I. PROCEDURAL HISTORY

- 1. On 14 August 2023, the Chamber appointed a panel of experts (the 'Panel') to examine Mr Said for the purposes of rule 135 of the Rules (the 'Decision Appointing Experts'). In the Decision Appointing Experts, the Chamber ordered, *inter alia*, the Defence to seek Mr Said's consent for the disclosure of his medical record, detention record and reports by the Medical Officer to the Panel no later than 21 August 2023.
- 2. On 21 August 2023, the Defence notified Mr Said's qualified consent to disclosure of the abovementioned information to the Panel.² In relation to the medical record, Mr Said limited his consent to items which he himself had received.³ The Defence further annexed a letter from Mr Said to the Registry [REDACTED].⁴

II. ANALYSIS

3. The Chamber has taken note of Mr Said's qualified consent. It understands from this that he wishes [REDACTED] and that he has no principled objection to the disclosure of information to the Panel for the purposes of facilitating its examination.

- 5. In respect of Mr Said's requests to the Registry for additional information, the Chamber encourages the Registry to continue to engage cooperatively with Mr Said on this matter.
