## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

### A. Disclosures made:

3. On 15 May 2024 the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 139” containing 9 items, “Trial INCRIM package 140” containing 1 item, “Trial Rule 77 package 107” containing 12 items, “Trial Rule 77 package 108” containing 2 items and “Trial Other package 024” containing 1 item.

4. On 23 May 2024 the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 141” containing 14 items and “Trial Rule 77 package 109” containing 2 items.

5. On 24 May 2024, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 142” containing 2 items.
