NOTING the Decision assigning the situation in the Democratic Republic of Congo

("the DRC") to Pre-Trial Chamber I, issued by the Presidency on 5 July 2004;1

NOTING article 39(2)(b)(iii) of the *Rome Statute* ("the Statute") pursuant to which the

functions of the Pre-Trial Chamber shall be carried out either by three judges of the

Trial Division or by a single judge in accordance with the Statute and the Rules of

Procedure and Evidence;

NOTING article 57(2)(b) of the Statute, pursuant to which a single judge of the Pre-

Trial Chamber may exercise the functions provided for in the Statute, unless

otherwise provided for in the Rules of Procedure and Evidence or by a majority of the

Pre-Trial Chamber:

NOTING rule 7(1) of the Rules of Procedure and Evidence and regulation 47(1) of the

Regulations of the Court, pursuant to which the designation of a single judge shall be

based on criteria agreed upon by the Pre-Trial Chamber, including seniority of age

and criminal trial experience;

CONSIDERING that at this stage of the proceedings in the Situation in the DRC and

any related case, the designation of a single judge will ensure the proper and efficient

functioning of the Chamber;
