NOTING the "Decision authorising the Prosecutor and the Defence to submit

observations on the applications of applicants a/0004/06 to a/0009/06,

a/0016/06 to a/0046/06 and a/0047/06 to a/0052/06 in the case of *The Prosecutor*

v. Thomas Lubanga Dyilo"1 ("the Decision") rendered on 4 August 2006 by

Judge Sylvia Steiner, acting as single judge in Pre-Trial Chamber I ("the

Chamber");

NOTING the "Request for Access to the Unredacted Versions of the

Applications of Applicants a/0004/06 to a/0009/06, a/0016/06 to a/0046/06 et

a/0047/06 to a/0052/06, and for an Extension of Time"2 (" the Request") filed

by the Defence on 14 August 2006 asking (i) if leave to appeal the decision of

28 July 2006 is granted, to stay the proceedings vis à vis the applications of

a/0004/06 to a/0009/06, a/0016/06 to a/0046/06 and a/0047/06 to a/0052/06; or,

in the alternative, if leave to appeal the decision of 28 July 2006 is not granted,

(ii) to order the Registry to provide the Defence with the unredacted versions

of the applications; and (iii) to order that the deadline for responding to these

applications shall not commence to run for the Defence until after the

confirmation hearing;

NOTING the "Prosecution's Request for an extension of a deadline" filed by

the Prosecution on 16 August 2006 requesting the extension of the deadline by

one week in order to respond to the applications for participation of

applicants a/0047/06 to a/0052/06;

NOTING the "Decision on the Temporary Substitution of the Single Judge"⁴

rendered by the Chamber on 11 August 2006, temporarily appointing judge

Claude Jorda as single judge in the case of Thomas Lubanga Dyilo and

making him responsible for exercising the functions of the Chamber in this

case pursuant to 57 (2) of the Rome Statute ("the Statute"), in particular those

set out in rule 121 (2) (b) of the Rules of Procedure and Evidence ("the

Rules");

NOTING articles 57 (3) (c) and 68 (1) of the Statute, rule 89 (1) of the Rules

and regulation 35 of the Regulations of the Court;

CONSIDERING that during the process of applications for participation, the

protection of applicants requires communication to the Defence of the

redacted versions of the said applications for participation;

CONSIDERING that the redacted versions disclosed to the Defence provide

the Defence with sufficient information for it to make submissions on the

question of whether the applicants may be granted the status of victim;

CONSIDERING that, although the Decision was rendered on 4 August 2006,

the Defence received the redacted versions of the forty-three applications for

participation only on 9 August 2006, and the Prosecution received the forty-

three applications for participation only on 8 August 2006, thus reducing the

deadline for submitting their observations;
