

On 22 May 2008, following the Single Judge's Order,¹ the Office of the Prosecutor ("Prosecution") filed its "Application Pursuant to Rule 81(2) and Rule 81(4) for Redactions in Compliance with Appeals Chamber's "Judgment on the appeal of the Prosecutor against the decision of Pre-Trial Chamber I entitled "First Decision on the Prosecution Request for Authorisation to Redact Witness Statements" ("Application") in two parts: Part I² and II.³ Annex 1, appended to Part I, provides the list of annexes containing the statements, interview notes, transcripts and documents that are the subject-matter of the Application.⁴ Because of a clerical error made in sub-Annexes S1, S2 and S4 the Prosecution is re-submitting herewith S1, S2 and S4 on a "confidential, *ex parte*, Prosecution only"⁵ basis for the Single Judge's consideration.
