

On 2 June 2008, the Office of the Prosecutor (“Prosecution”) filed the “Prosecution’s Application for Redactions to Evidentiary Material of Witnesses 132 and 287 Pursuant to Rule 81(2) and Rule 81(4) and Request for Authorisation to Rely at the Confirmation Hearing on the Summary of the Statement of Witness 243”¹ in which it requested authorisation to rely on the summary of Witness 243. In doing so, the Prosecution submitted as Annex C 2 the transcript of a conversation which establishes her consent to have the summary used at the Confirmation Hearing. Due to a clerical error contained in such annex, the Prosecution is re-submitting herewith Annex C 2 on a “confidential, *ex parte*, Prosecution only” basis requesting redactions to the transcript of Witness 243’s telephone conversation with the OTP, pursuant to rule 81(2) and 81(4) of the Rules of Procedure and evidence. Annex C 3 contains a table which depicts the proposed redactions and the underlying legal and factual reasons for the proposed redactions.
