- PRE-TRIAL CHAMBER III ("the Chamber") of the International Criminal Court
 ("the Court") intends to unseal certain documents in the case of *The Prosecutor v*. *Jean-Pierre Bemba Gombo*;
- 2. On 25 August 2008, the Single Judge¹ held a status conference² during which the Prosecutor was asked whether he objected to making public three geographic maps of Bangui and one map of the Central African Republic featuring in annexes 7 and 8 to the "Prosecutor's Application for Warrant of Arrest under Article 58".³
- 3. The Chamber notes articles 57(3)(c), 67 and 68(1) of the *Rome Statute*, rule 15 of the *Rules of Procedure and Evidence*, regulations 8(c) and 23bis of the *Regulations of the Court* and regulation 14 of the *Regulations of the Registry*.
- 4. In accordance with regulation 23 *bis* of the *Regulations of the Court*, the Chamber considers that the classification under seal *ex parte* only available to the Prosecutor is no longer necessary since these maps are in the public domain and do not reveal any information about ongoing investigations.

FOR THESE REASONS, THE CHAMBER DECIDES

to unseal the following documents which are made public:
