 On 14 July 2008, the Office of the Prosecutor ("Prosecution") filed under seal, an Application under Article 58 of the Rome Statute, requesting that Pre-Trial Chamber I issue a Warrant of Arrest for Omar Hassan Ahmad AL BASHIR ("Application")<sup>1</sup>.

2. On 21 August 2008 the Prosecution filed a Corrigendum<sup>2</sup> to the Application.

3. On 28 January 2009, the Prosecution filed a Notification to the Chamber Pursuant to Articles 54(3)(f) and 68(1) of the Rome Statute.<sup>3</sup>

4. On 30 January 2009, the Pre-trial Chamber issued a decision entitled "Decision scheduling an Ex Parte Hearing and Providing an Agenda"<sup>4</sup>. In the decision the Chamber scheduled an Ex Parte Hearing to be held on 3 February 2009 and attached a confidential annex<sup>5</sup> which contained the agenda for the hearing and listed a number of questions addressed to the Prosecution.

5. Pursuant to the requests contained in the agenda referred to above, the Prosecution attaches to this filing Confidential ex parte Annex 1, containing its written submission to the questions addressed to it in the hearing agenda.

6. The Prosecution further attaches to this filing as confidential Annex 2 to 5 materials referred to in its submissions contained in Annex 1.
