- 1. On 6 December 2010, the Prosecution filed its Objection to the Continued Representation of Victims a/1646/10 and a/1647/10 by Messrs Geoffrey Nice and Rodney Dixon¹ ("Objection").
- 2. On 6 December 2010, the Single Judge issued an Order² ("Order") to the Defence and the Legal Representatives of Victims a/1646/10 and a/1647/10 to submit a response to the Objection by 7 December 2010 at 14h00.
- 3. At the time it received the Order the Defence teams of Abdallah Banda Abakaer Nourain and Saleh Mohammed Jerbo Jamus ("Defence") were busy preparing the Defence Application to restrain legal representatives for the victims a/1646/10 & a/1647/10 from acting in proceedings and for an order excluding the involvement of specified intermediaries³ ("Application"). The Application was filed On 6 December 2010 at 21h51, and notified to the Chamber, parties and participants on 7 December 2010 at 10h41.
- 4. At paragraph 4 of its Application the Defence states that "[i]n compliance with the Order of the Single Judge, the Defence hereby informs the Chamber that it supports the Prosecution Objections to the extent that they are not otherwise inconsistent with the present application." The Defence notes that the Application was an independent submission and not a response to the Objection.
- 5. In order to ensure that it fully complies with the Single Judge's Order, the Defence hereby submits this response to the Prosecution's Objection, and affirms its position as detailed at paragraph 4 above.
