Other

- 1. Pursuant to regulation 35 (1) of the Regulations of the Court, the Defence respectfully requests that the Honourable Pre-Trial Chamber extend the deadline for responding to the Chamber's 'Decision Pursuant to Regulation 24(1) of the Regulations of the Court' (the Order), until 4pm Tuesday 5 April 2011.
- 2. At 2.45pm today (Monday 4 April 2011), counsel was alerted to the fact that the Honourable Pre-Trial Chamber had issued the Order that the Defence respond to the Observations of the Registry concerning the linguistic capability of Mr. J. Sang.
- 3. Although the Order appears to have been sent to the email address of counsel's office, the Defence have verified that the office did not receive the court document. Moreover, counsel for the co-defendants also did not receive this email, notwithstanding the fact that their email addresses appear to have been included within the notification page. The Defence were also not aware of the observations of Registry prior to Monday 2.45pm.
- 4. Regulation 24(1) of the Regulations of the Court enshrines the right of the defence to respond to any document filed by a participant. Whilst the Chamber possesses the power to vary any deadlines, the deadline imposed must nonetheless ensure that the right to respond on such a fundamental issue is effective and not illusory.
- 5. It is not possible for the Defence to consult with Mr. J. Sang and prepare a meaningful response to the observations of the Registry by 4pm 4 April 2011.
- 6. The Defence further observes that the normal deadline for filing a response (21 days) was significantly shortened in the present case (since the deadline for filings issued on a Friday does not commence to run until the next working day, the time allocated to respond is effectively zero days), at a time when counsel and client were in transit, and have been occupied with important logistical arrangement for the initial appearance.
- 7. The Defence is of course appreciative of the fact that the Chamber may need to render a preliminary determination of this issue in order to make suitable arrangement for the

initial appearance. The Defence nonetheless respectfully submits that the requested extension of the deadline is extremely modest and will enable the Chamber to render a decision before the initial appearance.

Relief Requested

8. For the reasons set out above, the Defence respectfully requests the Honourable Pre-Trial Chamber to extend the deadline for the Defence response until 4pm Tuesday 5 April 2011.
