**NOTING** rules 15 and 63(2) of the Rules of Procedure and Evidence; regulation 23bis of the Regulations of the Court; and regulations 28 and 53 of the Regulations of the Registry;

**CONSIDERING** that the Chamber instructed the Registry to assign EVD-PT numbers to the list of documents to be used for the purposes of the confirmation hearing;

**CONSIDERING** that the Chamber instructed the Registry on 5 October 2011 to review the assignment of EVD numbers to the items the Prosecution and Defence incorrectly referred in their respective lists; <sup>11</sup>

**CONSIDERING** that EVD-PT references were attributed to the redacted version of those documents included in both Prosecution and Defence lists of evidence;

**CONSIDERING** that redacted versions of the documents are referenced in the Ecourt portal with the suffix "-R01" instead of the suffix "\_R01";
