The Registrar of the International Criminal Court (“the Court”):

NOTING the "Decision Regarding Medical Care for Saif Al-Islam Gaddafi"¹ dated 9 March 2012;

NOTING Rule 176(2) of the Rules of Procedure and Evidence and Regulation 23 *bis* of the Regulations of the Court;

CONSIDERING that Pre-Trial Chamber I (“the Chamber”) ordered the Registry “to immediately arrange with the Libyan authorities for one or more medical professionals to meet Saif Al-Islam Gaddafi in order to address [his] health concerns [...]”²;

INFORMS the Chamber as follows:

1. The Registry undertook the necessary consultations with the Libyan authorities for adequate medical care to be provided to Saif Al-Islam Gaddafi;
2. On 13 April 2012, a representative of the Libyan authorities informed the Registry by e-mail that the medical treatment had been provided to Saif Al-Islam Gaddafi which included the general medical check up by a doctor and dental treatment. He also informed the Registry that the dentist would visit him again shortly (e-mail in annex).
3. The Registry filed the annex confidential in order to protect the identity of the medical personnel and of the Libyan representatives as well as of the staff members of the Court.
