Trial Chamber III (“Chamber”) of the International Criminal Court in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo* issues the following Decision on the Registry’s “Enregistrement d’une lettre de M. Jean-Pierre Bemba Gombo datée du 5 décembre 2013”.

1. On 28 November 2013, the Chamber convened a public status conference to discuss, *inter alia*, the issue of the legal representation of the accused.<sup>1</sup> During the status conference, the Chamber sought the accused’s views on the composition of the defence team representing him.<sup>2</sup> At that time, the accused asked for additional time to confirm the final configuration of his defence team.<sup>3</sup>
2. On 3 December 2013, the Chamber requested further information as to the state of the arrangements in relation to the legal representation of Mr Bemba.<sup>4</sup>
3. On 6 December 2013, the Registry filed its “Enregistrement d’une lettre de M. Jean-Pierre Bemba Gombo datée du 5 décembre 2013”,<sup>5</sup> transmitting to the Chamber a letter from Mr Bemba in which he confirms that, while he has yet to resolve the issue of the final composition of his defence team, for the time being, Mr Peter Haynes will continue to represent his interests before the Chamber.<sup>6</sup>
4. In accordance with Article 21(1) of the Rome Statute (“Statute”), the Chamber has considered the following provisions: Articles 64(2) and (6)(f), and 67(1)(b) and (d) of the Statute.


