I. Introduction

1. The Office of the Prosecutor ("Prosecution") herewith submits this Communication Report ¹ regarding Incriminating, Rule 77 and potentially exculpatory evidence disclosed to the Defence team of Narcisse Arido on 24 March 2014 through the Office of Public Counsel for the Defence (OPCD).²

2. On 20 March 2014, the Single Judge of the Pre-Trial Chamber II ("Single Judge") ordered the Prosecution "to disclose to the suspect and to put him up-to-date for the confirmation phase together with the other suspects all evidence until today disclosed to the other suspects".³

II. Request for Confidentiality

3. The Prosecution requests that Annexes A, B and C, appended to this Report, be received as "Confidential" as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. Submissions

4. The *Confidential* Annexes to this Report list evidentiary items already disclosed to the Defence teams of Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo and Fidèle Babala Wandu, respectively and which have now been disclosed to the Arido Defence.
