I, Judge Cuno Tarfusser, having been designated as Single Judge of Pre-Trial Chamber II of the International Criminal Court;

NOTING the "Enregistrement de la désignation de Maître Catherine Mabille en qualité de conseil adjoint dans l'équipe de la défense de M. Aimé Kilolo Musamba" dated 10 February 2014¹;

NOTING the "Demande de Me Catherine Mabille afin d'être autorisée à se retirer du dossier en qualité de Conseil adjoint *pro bono* de Mr Aimé Kilolo Musamba" dated 8 April 2014 ("Request")², wherein Catherine Mabille informs the Chamber that her mandate has been terminated by Aimé Kilolo Musamba and, accordingly, requests leave to withdraw from the case;

NOTING the "Annexe A confidentielle" to the Request, dated 2 April 2012, wherein Aimé Kilolo Musamba declares, in a signed manuscript paper, the termination of the mandate of Catherine Mabille³;

NOTING article 67 of the Statute, rules 20, 21 and 22 of the Rules of Procedure and Evidence and regulations 23*bis* and 78(1) of the Regulations of the Court;

CONSIDERING that, since Catherine Mabille was appointed as "Conseil adjoint" in the defence team for Aime Kilolo Musamba, the termination of her mandate does not affect either the continuity of his representation or his ability to fully exercise his rights under article 67 of the Statute;

NOTING that, although the Request and the Annex thereto are filed as confidential, no factual or legal basis has been stated as warranting the chosen classification;

CONSIDERING that, whilst the confidentiality of the reasons leading to a change of counsel or of the composition of a defence team might be warranted,

there are no reasons justifying the confidentiality of amendments to the composition of a defence team;

FOR THESE REASONS, THE SINGLE JUDGE HEREBY

DECIDES that the Request (ICC-01/05-01/13-321-Conf) shall be reclassified as public;

GRANTS leave to Catherine Mabille, Defence counsel *pro bono* for Aimé Kilolo Musamba, to withdraw from the case.
