Victims and Witnesses Unit Detention Section On 25 April 2014, the Single Judge ordered the Registry "to liaise with the Prosecutor and Defence teams, with a view to making it possible for them to be present upon the ... forensic acquisition of the DVD's [containing the Email accounts of Aime Kilolo and Jean-Jacques Mangenda"] if they so wish" [emphasis added] ("the forensic acquisition").

Jean-Pierre Bemba Gombo ("the Suspect") wishes – indeed insists - that herein undersigned Counsel be present at the aforementioned forensic acquisition. It is his right. Even the Single

Judge said so and ruled so. The forensic acquisition has been fixed for 22 May 2014.

The Registrar has denied the Suspect financial legal assistance twice and the Presidency is yet to rule on Counsel's request for judicial review of the Registrar's second decision.

Counsel made his [REDACTED] request for [REDACTED] on 3 March 2014. The Single Judge has delivered no decision on this request.

Consequently, the Suspect has had no ability to conduct any form of defence investigation.

Herein undersigned Counsel has not been paid throughout the life of this case and is forbidden from funding the Suspect's costs and expenses out of his own pocket.

In light of the aforementioned, the Single Judge is requested to rule, forthwith, on the [REDACTED] Defence request for [REDACTED]. Failing the aforementioned, the Single Judge is requested to order the suspension of the forensic acquisition until the Suspect is provided with the financial means to permit him to pay herein undersigned Counsel to be in attendance at the said procedure.
