- 1. On 21 August 2014, the Prosecution submitted the "Prosecution's eighth application pursuant to Regulation 35(2) of the Regulations of the Court"¹ seeking leave to add 57 items to its List of Evidence ("LoE"). On 29 August 2014, it filed an Addendum² seeking to add a further 23 documents.
- 2. After receiving responses from the Defence,³ a reply from the Prosecution,⁴ and further oral argument on the matter,⁵ Trial Chamber V(A) permitted the inclusion of the 80 additional items on the Prosecution's LoE⁶ and ordered, *inter alia*, that the Prosecution file its updated LoE into the record of the case forthwith.
- 3. The Prosecution hereby files as Annex 1 a confidential version of its updated LoE. Redactions contained in the previous version of the Updated LoE⁷ pertaining to P-0604 and P-0613 have now been lifted.
