Trial Chamber III ("Chamber") of the International Criminal Court in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo* ("Bemba case") issues the following Decision on the "Addendum to Prosecution's Request for Reclassification of 40 admitted Documents as Public and for Application of Redactions" ("Decision").

- On 24 January 2014, the Office of the Prosecutor ("prosecution") filed its "Prosecution's Request for Reclassification of 40 admitted Documents as Public and for Application of Redactions" ("Request 2946"),¹ in which it proposes redactions to a total of 40 documents, including, inter alia, item CAR-OTP-0010-0170 R03.²
- 2. On 26 May 2014, the Chamber issued its "Decision on the 'Prosecution's Submissions pursuant to the Order on the classification of items admitted into evidence' and other evidentiary issues", in which it, inter alia, postponed its decision on the reclassification of items CAR-OTP-0064-0547 (EVD-T-OTP-00119) and CAR-OTP-0010-0170_R03 (EVD-T-OTP-00047) and ordered the prosecution to submit proposals for redactions or to inform the Chamber that they could be reclassified as public with no redactions, within two weeks of the notification of such decision. As to item CAR-OTP-0010-0170_R03, the Chamber noted that it contained two written statements, but the prosecutor had proposed redactions only in relation to the first statement, omitting to propose redactions to the second statement starting at ERN CAR-OTP-0010-0192.5

- 3. On 11 June 2014, the prosecution filed its "Addendum to Prosecution's Request for Reclassification of 40 admitted Documents as Public and for Applications of Redactions, ICC-01/05-01/08-2946, 24 January 2014" ("Request 3088"), 6 submitting proposals for redaction of items CAR-OTP-0064-0547 and CAR-OTP-0010-0192, and requesting their reclassification as public with redactions.7
- 4. In accordance with Article 21(1) of the Rome Statute ("Statute"), the Chamber has considered Articles 64(2), 64(6)(c), 64(7), 64(10), 67(1), 68 and 69(5) of the Statute, Rule 137(2) of the Rules of Procedure and Evidence, Regulations 20(3), 21(7), 23bis(3) and 26 and of the Regulations of the Court and Regulations 10, 14 and 18 of the Regulations of the Registry.
- 5. Having reviewed the proposals for redactions submitted by the prosecution, the Chamber is satisfied that the redactions are necessary, limited and sufficient to protect witnesses, victims or any third persons at risk on account of the Court's activities. As such, the Chamber is satisfied that the abovementioned items can be reclassified as public once the redactions proposed by the prosecution in Annex 31 of the Prosecution Submission 2946, and Annexes 1 and 2 to the Prosecution Submission 3088 are applied.
- 6. In view of the above, the Chamber hereby:
 - a) GRANTS the prosecution's request to reclassify as public item CAR-OTP-0010-0170_R03 (EVD-T-OTP-00047), with the redactions proposed in Annex 31 of the Request 2946, except for pages 24 to 33

- of Annex 31,8 which should be replaced by the redactions proposed in Annex 2 of the Request 3088;
- b) GRANTS the prosecution's request to reclassify as public item CAR-OTP-0064-0547 (EVD-T-OTP-00119), with the redactions proposed in Annex 1 of the Request 3088; and
- c) ORDERS the prosecution to upload public redacted version of items CAR-OTP-0010-0170_R03 (EVD-T-OTP-00047) and CAR-OTP-0064-0547 (EVD-T-OTP-00119) to eCourt, implementing the redactions authorised in sub-paragraphs a) and b) above.
