#### I. Introduction

1. On 4 May 2016, Trial Chamber III (the "Chamber") issued the "Decision on requests to present additional evidence and submissions on sentence and scheduling the sentencing hearing" (the "Decision").<sup>1</sup>

2. In its Decision, the Chamber ordered the Victims Participation and Reparations Section of the Registry to provide the parties with a lesser redacted version of applications of victims a/0555/08 and a/0480/08 (the "Applications"), lifting any redactions to their identities and maintaining redactions to the identities of third parties, the victims' addresses, and/or other sensitive or personal information unrelated to the proceedings, no later than 13 May 2016.<sup>2</sup>

#### II. Classification

3. In accordance with the Chamber's Decision and pursuant to regulation 23bis (1) of the Regulations of the Court (the "ROC"), the lesser redacted version of the Applications are submitted as confidential annexes to the present filing.

#### III. Applicable Law

4. The Registry submits the present filing in accordance with articles 68(1) and (3) of the Rome Statute, rules 16 and 89 of the Rules of Procedure and Evidence and regulation 86 of the ROC.
