I - Introduction

1. The Registry hereby reports on the implementation of the “Decision on the Conduct of the Proceedings following the ‘Admissibility Challenge by Dr. Saif Al-Islam Gadafi pursuant to Articles 17(1)(c), 19 and 20(3) of the Rome Statute’” (“Decision” and “Admissibility Challenge”, respectively),¹ in which Pre-Trial Chamber I ordered the Registrar to:

“(…)

(c) provide the OPCV with information about victims who have already communicated with the Court in relation to the present case and any necessary assistance to contact such victims as soon as possible; and

(d) notify the [Decision] as well as document ICC-01/11-01/11-640, together with its public annexes, to the Security Council.”

II - Classification

2. In accordance with regulation 23 *bis*(1) of the Regulations of the Court, the annex to the present report is classified as confidential as it contains names and contact details of staff members of the Court and of the requested International Organisation.

III - Submissions

3. Pursuant to rule 59(2) of the Rules of Procedure and Evidence, the Registrar has transmitted the Admissibility Challenge and the public annexes thereto to the Security Council and the victims who have communicated with the Court in relation to the present case (“Case”), five in total.
4. Regarding the implementation of order (c) of the Decision: on 19 June 2018, the Registry provided the Office of Public Counsel for victims (“OPCV”) with a memorandum outlining the details of the five victims who have communicated

with the Court in relation to the Case,² as well as information pertaining to how best to communicate with these victims. In addition, the Registry provided the OPCV with access to the relevant victim application forms.

5. As to the implementation of order (d) of the Decision, the Registry contacted the Office of Legal Affairs in New-York (USA) on 20 June 2018 to inform them of the Decision. It also inquired about the best way to proceed for the notification of document ICC-01/11-01/11-640 and related annexes, considering their volume. However, due to the lack of staff members in the New York Liaison Office, the Registry was only able to formally notify the said documents *via* DHL on 2 July 2018.
