I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits the following response to the YEKATOM Defence's Motion for the Review and Reclassification of *Ex Parte* Filings ("Motion").¹

2. The response is limited to Prosecution filings² and does not comment on those of the Pre-Trial Chamber, NGAISSONA's Defence, Registry, or documents otherwise inaccessible to the Prosecution.

II. SUBMISSIONS

A. No Reclassification

3. The Prosecution filings set out below should not be reclassified, particularly where there has been no change in circumstances since the Pre-Trial Chamber rejected previous Defence requests, such as the Prosecution's Warrant of Arrest Application and related filings.³ Absent such change, the prevailing circumstances preclude reclassification. The same applies to other filings that concern various protective measures.

- 7. The Prosecution will provide the Chamber with the proposed redactions by 9 September 2019.

D. Motion aspects that are moot

8. The Defence's request in respect of filing ICC-01/14-01/18-237-Conf-Exp-AnxB is moot. The Defence already has access to the cover filing. Annex B thereof, which contains the summary of Witness P-1792's statements, was disclosed to the Defence *via* the regular disclosure process on 9 August 2019.⁷
