The Appeals Chamber of the International Criminal Court,

Having before it the ‘Requête de la Défense afin d’obtenir que la Chambre d’appel restitue à Laurent Gbagbo, acquitté de toutes les charges portées contre lui, l’intégralité de ses droits humains fondamentaux’ of 7 October 2019, ICC-02/11-01/15-1272-Conf,

Having also before it the ‘Demande d’autorisation aux fins de présenter des observations écrites de la République de Côte d’Ivoire sur la “Requête de la Défense afin d’obtenir que la Chambre d’appel restitue à Laurent Gbagbo, acquitté de toutes les charges portées contre lui, l’intégralité de ses droits humains fondamentaux”, 7 octobre 2019, ICC-02/11-01/15-1272’ of 25 October 2019, ICC-02/11-01/15-1282,

Issues the following

ORDER

1. A hearing before the Appeals Chamber will be held on 6 (potentially extending to 7) February 2020 to hear submissions and observations on the application of Mr Laurent Gbagbo of 7 October 2019,¹ praying the Appeals Chamber to reconsider its judgment of 1 February 2019² which imposed conditions on the release of Mr Laurent Gbagbo and Mr Blé Goudé following their acquittal.³ Further directions on the conduct of the proceedings will be issued in due course.

2. The application of the Republic of Côte d'Ivoire of 25 October 2019⁴ to present written observations before the Appeals Chamber, pursuant to rule 103 of the Rules of Procedure and Evidence, on the Application of Mr Gbagbo is granted. The Republic of Côte d'Ivoire is invited to submit observations, not exceeding 12 pages in length, on issues arising in the aforementioned application, by 16h00 on 22 January 2020, and to attend the hearing scheduled on 6 (potentially extending to 7) February 2020.
3. The parties and the Office of Public Counsel for Victims are invited to respond orally to the abovementioned written observations of the Republic of Côte d'Ivoire at the aforementioned hearing.
