I. INTRODUCTION

1. The Prosecution hereby notifies Trial Chamber I ("Chamber") of the disclosure of evidence pursuant to articles 64(3)(c) and 67(1)(a) and (b) of the Rome Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

II. CLASSIFICATION

2. This filing is classified as public with one confidential annex, comprising the list of evidence disclosed to the Defence. This annex is classified as confidential since it contains confidential information.

III. SUBMISSIONS

- 3. On 10 December 2021, the Prosecution disclosed to the Defence two packages of evidence consisting of 112 items (1.766 pages):
 - Pre-Trial INCRIM package 84, consisting of 79 items (1.067 pages), including material related to 31 witnesses;¹ and
 - Pre-Trial INCRIM package 85, consisting of 33 items (699 pages), including material related to 32 witnesses.²
- 4. With respect to redactions, the Prosecution re-disclosed items with less redactions and applied "standard" redactions to new items pursuant to the
