#### I. Introduction

1. Pursuant to Pre-Trial Chamber II ("Chamber")'s "Order setting the schedule for the filing of submissions in the proceedings pursuant to article 18(2) of the Rome Statute and rule 55(2) of the Rules of Procedure and Evidence", issued on 24 February 2022 ("24 February 2022 Order"),¹ the Registry hereby submits its final consolidated report on Article 18(2) victim representations received in the context of the situation in the Islamic Republic of Afghanistan ("Afghanistan" and "Situation").

## II. Procedural History

- 2. On 27 September 2021, the Prosecutor submitted a "Request to authorise resumption of investigation under article 18(2) of the Statute" ("Prosecutor's Request").<sup>2</sup>
- 3. On 8 November 2021, the Chamber issued a decision, in which it *inter alia* ordered the Victims Participation and Reparations Section ("VPRS") to: (a) start collecting victims' views and concerns in the context of the proceedings pursuant to article 18(2) of the Rome Statute ("Statute"); and (b) prepare a report including a brief assessment of whether criteria under rule 85 of the Rules of Procedure and Evidence ("Rules") are met and of the victims' views and concerns as to the Prosecutor's Request ("8 November 2021 Decision").<sup>3</sup>
- 4. On 25 November 2021, the Chamber issued a second decision in which it instructed the VPRS to submit a first report on the victims' views and

- concerns related to the Prosecutor's Request by Friday 17 December 2021, with further deadlines to be set in due course.<sup>4</sup>
- 5. On 17 December 2021, 28 January and 23 February 2022 respectively, the VPRS transmitted to the Chamber the first,<sup>5</sup> second<sup>6</sup> and third<sup>7</sup> batch of Article 18 victim representations received as well as the first,<sup>8</sup> second<sup>9</sup> and third<sup>10</sup> ("Third Report") reports on victim representations.
- 6. On 24 February 2022, the Chamber issued an order by which it, *inter alia*, (a) set the deadline of 8 April 2022 for all victims' views and concerns on the Prosecutor's Request to be submitted to the VPRS; and (b) instructed the VPRS to submit by 25 April 2022 to the Chamber all representations received by 8 April 2022, together with a final report thereon.<sup>11</sup>

#### III. Classification

7. Pursuant to regulation 23 *bis*(1) of the Regulations of the Court ("RoC"), Annex I to the present document is classified as "confidential" and Annexes II and III are classified as "confidential *ex parte*, only available to the Registry", because they contain confidential information that may lead to

the identification of victims. A public redacted version of Annex I will also be notified on the same day.

## IV. Applicable Law

8. The Registry submits the present filing in the context of article 18(2) and in accordance with article 68(3) of the Statute, rules 16(1) and 85 of the Rules, regulation 23*bis*(1) of the RoC and the 24 February 2022 Order.

#### V. Submissions

9. The Registry hereby transmits its final consolidated report on Article 18(2) victim representations (Annex I), together with its assessment of the representations received since its Third Report (Annex II) and a detailed explanation of the assessment criteria applied (Annex III).
