**PRE-TRIAL CHAMBER II** (the 'Chamber') of the International Criminal Court with this filing provides a lesser redacted version of the 'Warrant of Arrest for Joseph Kony Issued on 8 July 2005 as Amended on 27 September 2005' (the 'Arrest Warrant').

- 1. On 23 November 2022, the Prosecution asked the Chamber to issue a lesser redacted version of the Arrest Warrant (the 'Prosecution's Request').<sup>2</sup>
- 2. On 7 February 2023 the Chamber granted the Prosecution's Request, indicating that a lesser redacted version of the Arrest Warrant would be issued in due course.<sup>3</sup>
- 3. Considering that the Arrest Warrant was issued by a different composition of this Chamber, following a format that is nowadays no longer in use, the Chamber issues the lesser redacted version of the Arrest Warrant as a separate annex to the present filing.
