WITNESS STATEMENT

Procedure

- I was introduced to and told that they are investigators with the Office of the Prosecutor (OTP) of the International Criminal Court (ICC).
- 2. The investigators explained to me what the ICC is and described its mandate. They explained the role and mandate of the OTP within the ICC.
- The investigators explained to me that they are investigating events that took place in northern Uganda from 2002 to 2005. I was informed that the OTP is contacting me because they believe I may have information relevant for establishing the truth.
- 4. I agreed that the interview would be conducted in English. I fully understand and speak English.
- 5. The investigators explained to me that I do not have to answer to their questions. The investigators explained to me that they are seeking to find out the truth. I agree to tell the truth and that my answers to their questions are as complete as possible and reflect the best of my knowledge and recollection
- 6. I was informed that any information I give to the OTP, including my identity, may be shared with the parties of the proceedings at the ICC; in particular the Judges, Accused persons, the Counsel of the Accused and the legal representatives of the victims.
- 7. The investigators have explained to me the reasons and importance of keeping my contacts with the OTP confidential, which I fully understand.
- 8. Having understood all the above issues, I confirmed my willingness to answer the investigators' questions.
- 9. The investigators explained to me how the interview was going to be conducted. I was told that I needed to be as accurate as possible in my account and that I should state when I do not know the answer to or do not understand the question. I understand that I need to distinguish between what I have experienced or seen myself and what I have heard or learned about from someone else.

10. I was told that at the conclusion of the interview, I would be asked to sign a written statement after having had the opportunity to review it, make any corrections, or add additional information.

Documents

- 11. I have been asked to comment upon a number of documents that I understand were provided to the OTP. I was present at the Regional Police Headquarters in Gulu with my former colleague Assistant Superintendent on the 6th February 2016 and confirmed to the investigator which files contained potentially relevant documents
- 12. Investigators have showed me the following documents extracted from those files and asked me to explain their origin.

UGA-OTP-0256-0232 to 0233

- 13. By reviewing this document, I can see that it was sent by REGSEC NORTH which means Regional Security Officer North, which was my function in Special Branch when this document was dated, i.e 17 September 2003. The document was sent to the Director of the Special Branch in the Uganda Police HQ in Kampala.
- 14. The content of this report was based on the information I received from who was a communication officer in the Kamdini police post. The information derived from intercepted LRA communications on 17 September 2003 between 08:00 and 09:15 on frequency 8866. This document is not signed which indicates to me that it was created on my computer by my clerk Constable I. It would then have been sent electronically to Special Branch Headquarters. Another method of transmitting the information would have been by fax, and in that instance I would have signed the document or one of my deputies would have done so in my absence.
- 15. I can state that all documents that bear my signature were reviewed and authorised by myself before their being faxed to Kampala. I ensured that the information within the report appeared to be accurate and credible and conformed to Special Branch standards for intelligence handling. All my subordinates were aware of the same standards so I could be confident that they were dealing appropriately with the information in my absence.
- 16. Documents that do not bear my signature were sent electronically as stated above, however they were first drafted on plain paper by my clerk for my review and authorisation prior to him typing them upon the computer and sending them to Kampala.

17. Documents that have been signed on my behalf by my deputies in my absence were done so upon my authority as on occasion I had to travel into the field and was away from the office. Upon my return I reviewed all transmissions either by fax or electronically sent on my behalf.

- 18. This document dated 5 September 2006 was sent by myself as REGSEC NORTH to two senior Police Officers: SECINPOL K'LA (R), and REGPOL NORTH. They were the Director of the Special Branch in HQ in Kampala and the Regional Police Commander in Northern Region.
- 19. The initial part of information contained in this document was derived from MEGA FM radio and other the part was from human intelligence sources including retired who I actually met myself and obtained the information within the report. The report was signed by Police Constable on my behalf who was one of my clerks.

20. This document contained a list of people who left Gulu Airport on the 30th July 2006 for peace talks with the LRA in Juba. It was compiled by myself. I personally met these people and obtained their names before their departure.

21. By reviewing this document, I can say that the information in this document was derived from a human intelligence source or sources. The document was not signed by myself but signed by on 8 September 2005 as I was not on duty at that time. was my deputy and his rank was Assistant Superintendent.

22. This information report dated 9 August 2005 was signed by on my behalf. The report seemed to be based on human intelligence source. It was unconfirmed by other information.

23. This information report dated 6 April 2005 was signed by Assistant Inspector who was my staff officer.

24. The information in this document derived from LRA communication intercepted by of the Kamdini Police Post on the previous date 16 March 2005. I signed the document. It was sent to Kampala by fax.

25. The information in this report dated 3rd March 2005 derived from human intelligence sources and also contains details of LRA communications intercepted on 2 March 2005. I signed the document.

- 26. The report dated 17 February 2005 contains both information through human intelligence sources and details of LRA communications intercepted by of Kamdini Police Post on 16 February 2005. I signed the report.
- 27. The following documents are contained in the file titled Rebel Activities from other Districts.

UGA-OTP-0256-0245 to 0246

- 28. This report is a human intelligence information report on standard Special Branch stationary "SB Form 30" which gives the code of a source handler, the date the information was received by the source, and the date the information was received by the handler. The handler was HF 5 in this report. He was based in Pader District.
- 29. Intelligence is given a grading for accuracy and reliability. In this case, it was B2. Information classified as A1 was known to be true without any doubt.
- 30. The form was in triplicate with carbon paper between each page. The top copy was sent to me, the middle copy was sent to the District Special Branch, and the bottom copy was retained by the handler.

31. This report dated 5 May 2005 was brought to me in its original form. I can see that the time was 0255 hours, the location as Gulu, and heading as IMM meaning "Immediate" which indicated that information was required to be disseminated urgently. Therefore, it was urgently disseminated for my attention.

34. This report relates to intercepted communications on 16 October 2004 from of the Kamdini Police Post. It was sent by fax from my office to the Special Branch in Kampala but it was not signed. Therefore, this report had been sent by a computer electronically as there is no signature which normally indicates sending by fax.

35. This report dated 4 October 2004 is an incident report, relating to rebel activities on 3 October 2004. The report later contains intelligence derived from human a intelligence source. I signed the report.

36. The report dated 4 October 2004 is an information report relating to intercepted LRA communications on 2 and 3 October 2004 from of the Kamdini Police Post. I signed the report.

37. The report dated 3 October 2004 is an information report concerning LRA activities between 1 and 3 October 2004. I signed the report.

38. The report dated 19 September 2004 is an information report concerning LRA activities on 18 and 19 September 2004 derived from a human intelligence source. I signed the report.


59. The document is a list of LRA's top commanders. I created it by myself based on intelligence available to me at that time.

70. This document dated 5 August 2003 was sent from the District Special Branch in Pader District to myself as the Regional Special Branch Officer in the norther region. It concerns a number of people who were killed or injured in Oyuku village due to bombardment by a UPDF helicopter.

71. The report dated 30 July 2003 concerns LRA activities on 29 June 2003. In addition, it contains a report that 14 civilians were killed in Oyuku village on 24 July 2003. The information contained in the report was derived from a human intelligence source. I signed the report.

72. The report dated 24 July 2003 concerns LRA activities on 23 July 2003. The information contained in the report was derived from a human intelligence source. I signed the report.

- 73. This document dated 30 May 2003 addressed to the Assistant Inspector General of Police (SB) detailing the most recent command structure of the LRA. The information was based on human intelligence. I signed the cover letter.

75. This is a letter dated 3 December 2002 addressed to the Director of Special Branch in Kampala. It is a Northern Region security review covering from 15 December 2002 to 30 December 2002. I signed the letter.

76. The letter dated 20 November 2002 addressed to the Director of Special Branch in Kampala. It is a Northern Region security review covering from 1 November 2002 to 15 November 2002. I signed the letter.

- 77. I was informed that I may be called to testify before the Court. It was brought to my attention that ICC trials are held in public and explained to me that, as an exception to the principle of public hearings, the judges may apply protective measures to those testifying if circumstances require.
- 78. The investigators informed me of the protective measures that may apply during and after the investigation and/or trial proceedings.
- 79. I have nothing to add to the above statement nor do I have anything to clarify. I am available to be contacted in the future for clarifications or questions on topics not covered during this interview.
- 80. I have given the answers to the questions of my own free will.
- 81. There has not been any form of coercion, duress, threat, promise or inducement which has influenced my account.
- 82. I have no complaints about the way I was treated during this interview.

I have given this statement voluntarily and I am aware that it may be used in legal proceedings before the International Criminal Court and that I may be called to give evidence in public before the International Criminal Court
