Dear counsels,

The Chamber has duly considered the below communication as well as the *ex parte* (Chamber and Registry only) email dated 29 June 2022 at 16:58.

While the Chamber appreciates that the below circumstances are outside the Defence's control and that delaying the commencement of P-0111's testimony appears to be inevitable, it is of the view that P-0111's testimony must conclude before the summer judicial recess, that is by the 22<sup>nd</sup> of July.

Accordingly, the Chamber directs that the Defence and the Registry plan so that P-0111's testimony commence on the 14<sup>th</sup> of July at the latest. The Chamber acknowledges that this may require adjusting the standard pre-testimony activities, but finds that this is warranted by the present exceptional circumstances. The Chamber also understands that, as a result, the only remaining option is to hear P-0111's oral testimony via video link from the witness travel to the seat of the court. The Registry is directed to put in place the necessary arrangements.

The Defence request to delay the start of P-0111's testimony until 18 July is accordingly dismissed.
