The Chamber notes the submission of 14 items by the Prosecution following the testimony of P-0913 (*see* attached email of 29 August 2022 at 12:50).

The Chamber also notes the submission of 3 items by the Defence (*see* attached email of 29 August 2022 at 17:39). However, the Chamber finds that item DAR-OTP-00000022-R01 (P-0913 Preparation Note) was not used by the Defence during the hearing. Instead, the Defence relied on item DAR-OTP-00000012 (P-0913 Clarification & Correction Log), which is also submitted by the Prosecution. Consequently, the submission of item DAR-OTP-00000022-R01 (P-0913 Preparation Note) is rejected.

Noting that the other items tendered were used and discussed with P-0913, and that their submission is unopposed, the Chamber hereby recognises the items as formally submitted.
