Dear Counsel, dear colleagues from the Registry,

The Chamber takes note of the emails on the submission of evidence following the examination of P-2453 by the Ngaïssona Defence (*see attached* email from the Ngaïssona Defence, 27 June 2022, at 16:04), and the Prosecution (*see below* email from the Prosecution, 27 June 2022, at 17:38), as well as the Ngaïssona Defence's objections (*see below* email from the Ngaïssona Defence, 30 June 2022, at 13:11), and the Prosecution's response thereto (*see below* email from the Prosecution, 1 July 2022, at 17:30).

At the outset, the Chamber notes that items CAR-OTP-2001-1870, CAR-OTP-2075-1375, CAR-OTP-2081-0973, CAR-OTP-2122-9226 and CAR-OTP-2079-1158 have already been recognised, and therefore it need not rule on them again.

Moreover, the Chamber takes note of the Ngaïssona Defence's submissions concerning item CAR-OTP-2001-2308, in relation to which the Ngaïssona Defence argues that while it 'does not strictly speaking object to its submission [...], it would be prejudicial for the Trial Chamber to consider the extensive other content of item CAR-OTP-2001-2308 which was not discussed with the witness'. The Chamber notes that only page 2325 was shown to and discussed with the witness (see transcript of hearing, 23 June 2022, ICC-01/14-01/18-T-137-CONF-ENG, p. 24, line 6 to p. 25, line 3). The Chamber further notes that pages 2323-2325 have already been recognised as submitted in the context of P-2049, on the basis that 'these pages can be read and understood without requiring the item in its entirety for context [and thus considered it] warranted to depart from the general rule of submission of items as a whole' (see email from the Chamber, 23 August 2022, at 08:32). The Chamber therefore considers it appropriate not to recognise the entire item at this point, and recalls that it will assess the relevance, probative value and potential prejudice of the evidence as part of its holistic assessment in the context of its judgment deliberation.

In light of the above and in the absence of any procedural bars, the Chamber recognises as formally submitted the following items:


In accordance with paragraph 63(ii) of the Initial Directions on the Conduct of the Proceedings (ICC-01/14-01/18-631), I am writing on behalf of Counsel to respond to the below submission of materials.

Though the Defence does not strictly speaking object to its submission, the Defence notes for the record that it would be prejudicial for the Trial Chamber to consider the extensive other content of item CAR-OTP-2001-2308 which was not discussed with the witness. In its email 'Decision on submitted materials for P-2328' (1 October 2021 at 12h28), the Trial Chamber rejected the submission of a Facebook transcript where certain excerpts had been discussed in live testimony on the basis of the transcript's "nature and scope, compared to the extent to which they were used during P-2328's questioning".

Two pages of CAR-OTP-2001-2308 were raised with the witness and the witness had not heard about the events described therein (ICC-01/14-01/18-T-137-CONF-ENG, p. 24, l. 6 to p. 25, l. 3). This is despite the Presiding Judge prompting the witness with:

20 Mr Witness, when -- when you said people might have talked about what happened during other days.
20 And also when there have been hundreds of houses destroyed, perhaps you have 21 seen something afterwards.

Which the Witness dismissed noting "as to whether they killed people, set the village on fire, I'm not in a position to know." Since the witness could not even confirm such dramatic events, it would be prejudicial for the Trial Chamber to base its judgment upon material mentioned elsewhere in the other 139 pages without substantive argumentation being made by the Prosecution (i.e. as regards submission criteria) and the Defence being afforded the opportunity to make submissions on the Prosecution arguments.
