Dear Trial Chamber,

Dear All,

In view of the circumstances affecting current evidentiary block, and having proposed a way forward that is not agreed on by the Parties and Participants, the Prosecution informs that it intends for P-0487 to remain at HQ through Friday, 9 December. The witness has been here for some time now, has completed his familiarisation, and is prepared to go forward.

As the Chamber indicated earlier today that it will receive an update on [REDACTED] by Thursday, 8 December, there remains (at least in theory) a possibility that P-0487 might testify *soon* thereafter and that, with substantial support and accommodation by the Registry, his testimony might be completed. In this respect, the Prosecution defers to the Chamber. However, if the updated [REDACTED] information is not promising or reasonably certain, the Prosecution proposes to release P-0487 on Friday, and to call P-1858 to testify *via* AVL on Monday, 12 December to complete the Block. In that event, we would also seek an exception to the normal deadline to provide his Examination List.

The Prosecution is mindful of the legal, ethical, and practical issues argued this morning, and the complexity of the unusual circumstances faced. We hope to arrive at an acceptable and fair result, and appreciate the consideration and flexibility of all concerned.
