Trial Chamber IX recognised that the Expert Report in **tab 1** fulfils the requirements under rule 68(3) of the Rules of Procedure and Evidence (T-254-CONF-ENG ET, pp 4-5).

Item in tab **2.1** is a defence table of transcripts excerpts that was used by Counsel Lyons during the examination of D-0042 (T-255-CONF-ENG ET, pp 6-10). The Defence understands that the table is not on the Defence list of evidence and that it contains sections of witness testimonies that are already part of the *Ongwen* case record. However, for the completeness and clarity when referring back to the November 2019 expert witness testimonies and the materials used, the Defence requests, on an exceptional basis, that the Chamber permit the Defence to add the table to its list of evidence and recognise it as formally submitted.

In respect to the submission of item in **tab 5**, the Defence reiterates Mr Obhof's email of 27 November 2019 (Subject: Defence Submission of Material through Rebuttal Witness P-0447), in which he argued that 'this item, while not being on its list of materials for P-0447, was used during the Defence's examination of P-0447. It is also noted that the Prosecution had a physical copy of the DSM-5 in its possession. It is the Defence's position that the Prosecution was [not] disadvantaged by the use of the material in this item, and that for the completeness of the record, the Defence requests its submission into evidence'. Counsel Lyons used the item during the examination of P-0447 on 26 November 2019 (T-253-CONF-ENG ET, pp 96-97).

Dear Counsel and Registry:

For D-0042, the Prosecution submits 1 item for formal recognition (Email from the Prosecution, 25 November 2019, at 13:21).

The Defence requests that 12 items be recognised as formally submitted in relation to D-0042 (Email from the Defence, 25 November December 2019, at 14:48 and email from 2 December 2019, at 15:20).

The Chamber notes that five of the items submitted by the Defence were also submitted (and recognised as formally submitted) for D-0041. Accordingly, a second recognition as formally submitted is not necessary.

Further, as has been the case with D-0041, the Defence requests that two items be exceptionally submitted while not being on its List of Evidence.

The Chamber notes that one of the items identified by the Defence (UGA-D26-0015-0779) is actually on its list of evidence. Further, another item not identified by the Defence (UGA-D26-0015-1395) is actually not on its list of evidence.

The Chamber notes that one of the items (UGA-D26-0015-1472) is a short biography of the witness in question. The other item falls in the category as the one discussed during the testimony of D-0041 (transcript of hearing on 18 November 2019, T-248, pg 18, l.24 – pg 20, l.12).
