12 the OCRB and you also began giving other names. I'll ask you again: Aside from Mr

13 Said, who you mentioned yesterday, were there other people in a hierarchy of the

14 OCRB?

15 A. [10:01:46] He was Colonel Mahamat Saleh, Damboucha, and Tahir. But Tahir

16 wasn't there often, but Mahamat Saleh and Damboucha were there more frequently.

17 Q. [10:02:28] And what was their relationship to Colonel Mahamat Said?

18 A. [10:02:31] I don't know their relationship, because I wasn't very close to them. I

19 didn't know what the nature of their relationship was.

20 Q. [10:03:11] Then let's start with the name Damboucha you gave. Who was that and

21 what was he doing at OCRB, to your knowledge?

A. [10:03:17] What I noticed, what I saw, when there was Mahamat \*Sallet as well,

they looked at people who had been arrested. And each time he came with his vehicle,

24 there were individuals there who had been arrested. That is what I observed.

25 Q. [10:03:55] And who were these people who were arrested?

- 1 A. [10:04:21] I didn't understand your question.
- 2 Q. [10:04:23] Do you know who these people were that were arrested, brought by
- 3 Damboucha?
- 4 A. [10:04:28] I didn't know these individuals. There were many more Seleka, but for
- 5 what reason I don't know. I couldn't know that.
- 6 Q. [10:04:57] And you mentioned Damboucha bringing persons to OCRB. Can you
- 7 describe Damboucha for us?
- 8 A. [10:05:10] As I've said already, he was a colonel, just like \*Sallet, and it was those
- 9 two that brought them out and took action.
- 10 Q. [10:05:44] What do you mean by that, "those two who brought them out and took
- 11 action"?
- 12 A. [10:05:50] As I said, again, Mahamat \*Sallet and Damboucha left with their vehicle
- 13 and then when they returned to the OCRB, they took with them persons and they got
- 14 out. That's what I'm trying to say.
- 15 Q. [10:06:31] All right. Do you know where Colonel Damboucha is from?
- 16 A. [10:06:39] He originally comes from Mboya.
- 17 Q. [10:07:02] Can you repeat that name, please? Because it may have not been caught
- 18 by the translation. I'm sorry. Can you repeat that name?
- 19 A. [10:07:20] Damboucha came from Mboya.
- 20 Q. [10:07:33] I think, again, unfortunately, the name has not been captured properly.
- 21 I heard it in the original what he was saying.
- 22 Mr Witness, can you say it very clearly, the name of the town, so it's caught on the
- 23 transcript properly? I'm sorry to have to ask you this.
- A. [10:07:53] He came originally, Bria.
- 25 THE INTERPRETER: [10:08:09] B-r-i-a, says the interpreter.

- 1 MS VON BRAUN: [10:08:14]
- 2 Q. [10:08:14] And do you know what ethnicity Damboucha is?
- A. [10:08:17] \*He's from the Runga ethnic group, from Ndélé.
- 4 Q. [10:08:40] And then you mentioned Mahamat Saleh. Can you describe him for us,
- 5 please?
- 6 A. [10:08:43] Mahamat Saleh is also a Runga, but he came from Mboya.
- 7 Q. [10:09:12] Where did he come from?
- 8 A. [10:09:13] He came from Bria. He came from Bria. But the area where he carried
- 9 out his activities as a miner was in Nzako.
- 10 Q. [10:09:53] What mining activities do you mean?
- 11 A. [10:09:55] These are activities which he carried out under -- already when Bozizé
- 12 was in power and they assigned him the ranking of colonel.
- 13 Q. [10:10:30] And what was he mining?
- 14 A. [10:10:31] He was extracting diamonds and gold.
- 15 Q. [10:10:54] Is Mahamat \*Sallet his full name?
- 16 A. [10:10:56] No, that's what we know him as in the group. Just like his father, who
- 17 was called Adoum Kette. That was his father, Adoum Kette.
- 18 Q. [10:11:32] Okay. Now, the name Tahir you mentioned. What can you tell us
- 19 about Tahir?
- A. [10:11:40] I didn't work with him, but he was based behind the stadium.
- 21 According to the information I received is that he attacked a pregnant woman who
- 22 then died. He then sought refuge in the Beal Camp. But I repeat, I didn't work with
- 23 him so I don't have much information about him.
- 24 Q. [10:12:40] How often did you see him at the OCRB?
- A. [10:12:57] I saw him three times at the OCRB. The fourth time, I saw him the day

- 1 of the ceremony of disarmament.
- 2 Q. [10:13:14] What is his -- do you know what his full name is, or do you only know
- 3 him as Tahir?
- 4 A. [10:13:21] The name that I know is Tahir, Colonel Tahir.
- 5 THE INTERPRETER: [10:13:45] The Sango interpreter didn't catch the second name
- 6 which he made.
- 7 MS VON BRAUN: [10:13:55]
- 8 Q. [10:13:56] Can you repeat, because there was an interpretation problem, what you
- 9 just said, Mr Witness, in relation to the name.
- 10 A. [10:14:14] I repeat his name was Colonel Tahir Babikir. Tahir Babikir. I don't
- 11 know any other name for him. That's all I know as far as he's concerned.
- 12 Q. [10:14:40] All right. Now you mentioned a disarmament ceremony. Do you recall
- 13 when this ceremony was?
- 14 A. [10:14:43] I have forgotten the date.
- 15 (Redacted)

- 20 Q. [10:16:12] Thank you. Now, do you recall the names of anyone else working at the
- 21 OCRB aside from the names you just gave us today?

- 23 Both were captains. There was Commander Yaya, Mapouka Christian. There was
- 24 Colonel Mahamat Said -- he was the driver of Mahamat Said. As far as the other
- 25 persons concerned, you know, it's a long time ago, so I can't recall them very well.

- 1 Q. [10:17:27] I understand that. No problem. Then let's speak about Commander
- 2 Yaya. Who is this?
- 3 A. [10:17:35] He was part of the commanding team. He was part of the team who
- 4 carried out the patrols for disarmament.
- 5 Q. [10:18:24] Was Yaya his full name?
- 6 A. [10:18:29] That's the name I know. I know him as Commander Yaya.
- 7 Q. [10:18:51] And where was Yaya from?
- 8 A. [10:19:05] Commander Yaya also stayed in Bria.
- 9 Q. [10:19:17] And what was his ethnicity?
- 10 A. [10:19:19] He also is a Runga, his ethnic group.
- 11 Q. [10:19:38] And how often did you see him at the OCRB?
- 12 A. [10:19:40] He was regularly at the OCRB together with Colonel Tahir.
- 13 Q. [10:20:15] So what was his relationship to Tahir?
- 14 A. [10:20:17] Sorry, I didn't understand your question.
- 15 Q. [10:20:37] The transcript captured that you said, "Yaya was regularly at the OCRB
- 16 together with Colonel Tahir." So my question is what was their relationship? What --
- 17 did they have functions to perform together? Why were they together?
- 18 MS NAOURI: [10:21:10](Interpretation) Sorry, this is a leading question already. The
- 19 question, is there a relationship, firstly, not what are the relationship. And now we are
- 20 trying to explain the relationships which he might have. This is very, very leading.
- 21 MS VON BRAUN: [10:21:29] I withdraw the question.
- 22 PRESIDING JUDGE SAMBA: [10:21:31] Yes, can you --
- 23 MS VON BRAUN: [10:21:32] Yes, yes, I withdraw the question.
- 24 Q. [10:21:41] So, Mr Witness, was there a relationship between Tahir and Yaya?
- A. [10:21:45] In fact, I wanted to talk about Captain Ibrahim. I am not talking about

- 2 tribunal, and he went to the disarmament. And if it was scheduled, day or night, that's
- 3 what he had to do. That was his work.
- 4 Q. [10:22:30] Okay. And you mentioned Captain Ibrahim just now, that you wanted
- 5 to talk about him. Who is Captain Ibrahim?
- 6 A. [10:22:50] He's a Runga. That's his ethnic group.
- 7 Q. [10:23:12] And what was his role at the OCRB?
- 8 A. [10:23:14] His work was to be part of the disarmament process. He was part of
- 9 that team.
- 10 Q. [10:23:40] And you said there were two Captain Ibrahims, if I understood you
- 11 correctly. What did the other one do?
- 12 A. [10:23:53] He did the same work with disarmament. Both of them worked for
- 13 disarmament. \*However, he, that particular Ibrahim, was from the Banda ethnic
- 14 group, from Bria.
- 15 Q. [10:24:18] Now, these persons that you just mentioned, the names we discussed,
- 16 what were they wearing when they were at the OCRB?
- 17 A. [10:24:57] Sometimes they came in a uniform. Sometimes they also came as
- civilians. You know, they were officers and they did what they liked, and they worewhat they wanted.
- 20 Q. [10:25:37] And when they were in uniform, what type of uniform?
- A. [10:25:40] \*They had different attires; there were green army uniforms, uniforms
- from Sudan. \*And they also had some uniforms that were given to them by the Frenchsoldiers.
- 24 Q. [10:26:16] All right. Now, you mentioned Damboucha and Saleh bringing in
- 25 people to the OCRB. How would they -- how would these people be brought in?

- [10:26:42] I don't know the place where they arrested the individuals. But when --1 Α. I couldn't come near them to ask them when I saw them. They brought them in as 2 prisoners and left them there, but I couldn't ask them questions as regards where they 3 came from. 4 MS VON BRAUN: [10:27:31] Is it going too fast? Just a question. Okay. 5 O. [10:27:35] Were there vehicles at the OCRB? 6 7 A. [10:27:38] There were vehicles at the OCRB. \*There was a Harbody for Colonel 8 Said, there was a Hilux pickup and there was also a BJ75 vehicle, with a heavy weapon 9 mounted on it, and there were also two pickups that had been donated by the French. 10 Q. [10:28:36] And what type of vehicle is the vehicle you mentioned for Said? 11 А. [10:28:54] Hardbody, Hardbody, that was his vehicle. That's how he came to 12 work every day. It was a Nissan. 13 Q. [10:29:17] What colour was it? A. [10:29:19] When he was in the OCRB, he had a Hardbody that was white. When 14 he left the OCRB, he started to use one that was red in colour. 15 [10:29:55] All right. And these other vehicles that you mentioned, who used 16 Q. 17 them? [10:30:04] The other vehicles were used by Commander Yaya, Captain, and 18 А. 19 Christian, the colonel's driver. He was the one who drove the vehicle that had a heavy weapon mounted on top of it. 20 21 O. [10:30:42] Can you describe this heavy weapon, please? The heavy weapon, can you describe that? 22 23 A. [10:31:20] It was a DKM weapon.
- 24 Q. [10:31:47] Thank you. Now, yesterday you described a scene involving
- 25 Nouradine. Can you let us know whether Nouradine is the full name of the person

(Private Session)

- 1 you were mentioning?
- 2 A. [10:32:10] His full name is Nouradine Adam.
- 3 Q. [10:32:32] And what was his position in 2013?
- 4 A. [10:32:54] He was the minister of the interior.
- 5 Q. [10:32:57] And how often would he come to the OCRB?
- 6 A. [10:33:12] He would come to the OCRB, but it would depend. He might come
- 7 unannounced. That often happened. That's how things went.
- 8 Q. [10:33:40] And to your knowledge, what would he do at the OCRB when he came?
- 9 A. [10:33:43] When he would get information about various people, he would come
- 10 and talk to the colonel about these people; specifically, about the arrest of certain
- 11 people.
- 12 Q. [10:34:24] And when you say "the colonel," who do you mean?
- 13 A. [10:34:27] I'm referring to Colonel Mahamat Said, because he was the commander
- 14 of the base. So when Damboucha or Mahamat Saleh would arrest someone and he
- 15 would get that information, he would come to find out more, to get more details.
- 16 Q. [10:35:05] And from whom would he get details?
- 17 A. [10:35:07] I don't know where or from whom he got the information. But one
- thing for sure, when he came he would yell, he would talk -- he would be angry when
- 19 he spoke, and then he would leave.
- 20 Q. [10:35:45] Do you know why he was angry when he spoke?
- A. [10:35:49] He was responsible for the people who were at the OCRB. People
- 22 would be arrested and his role was to check all of that. That's my point of view.
- 23 Perhaps he received instructions from the president. So maybe that's why Mahamat
- 24 Saleh --
- 25 THE INTERPRETER: [10:36:39] And the Sango is not entirely sure about the following

Q. [10:36:58] Witness, the interpretation has not caught something, Mr Witness. You
mentioned two names. Can you repeat them, please?

9 A. [10:37:05] Very well. I talked about Colonel Mahamat \*Sallet. And, as far as I

10 know, one day, when I was at the OCRB, Saleh and Damboucha were talking. His

11 phone rang, he took the call, and he started to argue with the president in Arabic.

12 Sometime after that, he hung up, and he said to Damboucha, "He didn't buy any

ammunition, any weapons. We're going to use our ammunition, our weapons. We're

14 here and now we have to intervene," because in the meantime he had arrested a

15 Lebanese person and he had put him in the basement. And the Lebanese person had

16 given him money, and the Lebanese guy called the president to say that Mahamat

17 Saleh had arrested him and he was at the OCRB. The president intervened. He called

18 Mahamat \*Sallet, they argued, he hung up the phone, and he got into his vehicle and

19 left.

Shortly thereafter, Nouradine came with a number of elements. They wanted to arrest
him and take his vehicle. He refused. He walked to Camp de Roux where he talked to
the president, and he called Mahamat Saleh on the phone and he started to yell. He

23 was angry. He chewed him out, and then he left.

24 That's what I can tell you about that.

6 Somebody, you said, walked to Camp de Roux. Who are you referring to there?

7 A. [10:39:49] In response to your question about how often General Nouradine

8 would visit the OCRB, and where he got his information from, I gave you the example

9 of what Mahamat \*Sallet and Damboucha did. They would arrest people, they would

10 put them in cells. They maybe got the information -- personally, what I thought --

11 when I was at the OCRB, Mahamat \*Sallet and Damboucha were there. He would call

12 them -- they were his men. He would call them on the phone. And Mahamat \*Sallet

13 would say to Damboucha, "He hasn't bought ammunition for us. He hasn't bought

14 ammo for us," and "We have to manage for ourselves. Today, he wants to give us

15 instructions." And Mahamat \*Sallet and Damboucha started their vehicle and then

16 they left.

17 Shortly thereafter, General Nouradine --

18 Q. [10:41:10] Sorry, Mr Witness, you have to go slower because the interpreter will19 not be able to catch up with you. All right?

20 THE INTERPRETER: [10:41:18] Many thanks from the interpretation team.

21 MS VON BRAUN: [10:41:21]

and the Lebanese man. Now, my only question was, towards the end of your narrative

24 you said somebody then walked to Camp de Roux. Could you just clarify who walked

to Camp de Roux? It can also be not caught correctly, but just that clarification, please.

- 1 PRESIDING JUDGE SAMBA: [10:41:52] Could you read the sentence for him so that he
- 2 knows the area you're talking about.
- 3 MS VON BRAUN: [10:41:57] It's probably better, yeah. I'll just find it.
- 4 PRESIDING JUDGE SAMBA: [10:42:10] Mr Witness, you said:
- 5 "Nouradine came with a number of elements. They wanted to arrest him and take his
- 6 vehicle. He refused. He walked to Camp de Roux where he talked to the president."
- 7 Who walked to Camp de Roux?
- 8 THE WITNESS: [10:42:41](Interpretation) It was the minister, Nouradine. At that time,
- 9 he was still a minister. He received a call from the president about the Lebanese guy
- 10 who had been arrested by Mahamat \*Sallet. The president chewed him out. He came
- 11 to the OCRB. When he got there, they had already left and they left for Camp de Roux.
- 12 He called Mahamat \*Sallet and Damboucha on the telephone, and he yelled at both of
- 13 them. And then he went off.
- 14 MS VON BRAUN: [10:43:23]
- Q. [10:43:23] Thank you very much. The question has been clarified. So this is clearnow. Thank you.
- 17 Was there -- yeah, what else can you tell us about Nouradine Adam at OCRB? What
- 18 activities would he perform? What other activities would he perform, if any, at OCRB?
- 19 A. [10:43:55] I don't know.
- 20 Q. [10:44:17] On what other occasions did you see Nouradine Adam?
- A. [10:44:20] I would only see him when he came to the OCRB. I never went to see
- 22 him at his ministry, at his work.
- 23 Q. [10:44:53] And what ethnicity does Nouradine Adam belong to?
- A. [10:44:59] He is Runga from N'Dele, and his village of birth is Ndah.
- 25 Q. [10:45:39] Thank you very much. Now, you had spoken about Damboucha and

- 16 A. [10:47:38] I haven't understood your question.
- 17 Q. [10:47:56] All right. Maybe I will ask it differently. So when they were brought
- 18 into the compound, where would these people be put or brought?
- 19 A. [10:48:14] There were several cells in the compound. There was G1, G2, and G3,
- 20 and those people would be taken and put in those cells.
- Q. [10:48:48] And during the time that you were at OCRB, how were these peopletreated?
- A. [10:48:59] The head of the jail could tell you what happened to them. What I saw,
- 24 what I saw with my own eyes, was when Colonel Mahamat Said came and brought out
- certain people from the cells, and he would take them somewhere else.

- 16 people in the vehicle, (Redacted) What did you see -- can you describe

18 A. [10:52:27] The two people were tied up with the arbatachar method and placed in19 the back of the vehicle.

- 20 Q. [10:52:56] Can you describe that method, please? How were they tied up?

- 6 A. [10:54:59] \*Djidou was the aide-de-camp to Colonel Mahamat Saleh.

- 8 behind G3. Who left with the prisoners in the vehicle?
- 9 A. [10:55:36] Do you mean what I just said? Well, actually, Colonel Mahamat \*Sallet
- 10 came with the vehicle, (Redacted) Damboucha as well came in, (Redacted)

- 12 (Redacted) I saw them positioning the vehicle.

- 10 several incidents he mentioned in his rather fast summary.

2 Q. [11:35:34] Which cells were they taken out of?

A. [11:35:36] The last incident, I noticed that they were taken out of cell 2, but the first

7 A. [11:36:14] As I've already said, in the first incident there were two prisoners. The

8 other time, there was only a single prisoner. That's the second incident. And the third

9 incident, they took two persons. And the final incident, from cell 2 they took out a

10 single prisoner.

11 Q. [11:36:54] What happened to the prisoners when they were taken out of the cells?

12 A. [11:37:17] As I've already said, when the prisoners were taken out, they were tied

13 up according to the arbatachar method. They were put into the back of the vehicle and

14 drove towards the river, towards Hotel Sofitel. I don't know what happened over

- 15 there. I wasn't present to give you details.
- 16 Q. [11:37:44] In these three incidents, who tied the prisoners?

17 A. [11:37:47] It is the aide-de-camp of Mahamat \*Sallet named \*Djidou.

Q. [11:38:18] All right. Now, for each of those additional incidents, I would like youto describe when, or if at all, Mahamat Said was present.

20 A. [11:38:45] As I've said, the first incident he was absent. The second incident, he

21 was present when they took out the prisoners. The third incident, they came and he

22 came afterwards. And the final incident, they came together to get the prisoners out.

23 Q. [11:39:06] All right. Then let's start with the second incident. You say he was

24 present. What do you mean by that? Where was he exactly?

A. [11:39:19] As I've already said, regarding the second incident, he was in the

- 7 do you mean by "they" for this incident?

12 you repeat that? Who was taking vehicles in the direction of Sofitel for the third time?

13 A. [11:46:35] The first time, Damboucha and Colonel Mahamat \*Sallet. The two.

14 That was for the first incident. The second incident, Damboucha and Colonel Mahamat

15 \*Sallet. The third incident, Colonel Mahamat \*Sallet and Damboucha. The last incident

16 were Mahamat \*Sallet and his aide-de-camp Abdel and Damboucha and Djidou were
