- 12 I think that is quite a long narrative. We should perhaps ask specific questions that
- 13 you think are relevant, or move to another point. And perhaps we can, at some
- 14 point in time, go back to open session.
- 15 MR OBHOF: [10:23:42] Actually, she was coming to the point that I really wanted to
- 16 hear about, the charm. Yes, and if -- yes.
- 17 PRESIDING JUDGE SCHMITT: [10:23:51] No, I think the Prosecution will not object
- if I say you can direct a little bit more to the point here.
- 19 MR OBHOF: [10:23:57] Okay.
- 20 Q. [10:23:58] Now, Ms Witness, you said you were burying a charm to stop the
- 21 government soldiers from following you. Did that work?
- 22 A. [10:24:18] Yes, it worked. Only that I think the reason why it didn't work very
- 23 well was because these soldiers again, as they were moving, they didn't go far, they
- 24 had laid an ambush ahead.
- 25 Q. [10:24:42] Now when you were eventually captured, how did the soldiers treat

you?

- 2 A. [10:24:58] They did not mistreat us. They asked us, "Where were you going?"
- 3 We told them that we were escaping and they ask, "How many are you?" I told
- 4 them we were four. They ask if there were also men amongst us. We told them, no,
- 5 we were only women, we are only women and we are escaping.
- 6 MR OBHOF: [10:25:22] Now we can go back into open session, your Honour.
- 7 PRESIDING JUDGE SCHMITT: [10:25:26] Back to open session.
- 8 (Redacted)
- 9 (Redacted)

- 13 (Open session at 10.25 a.m.)
- 14 THE COURT OFFICER: [10:25:46] We are back in open session, Mr President.
- 15 MR OBHOF: [10:25:58]
- 16 Q. [10:25:59] Now, Ms Witness, when you were in the LRA did persons in the LRA
- 17 receive news about people who had been captured or escaped?
- 18 A. [10:26:26] Yes, sometimes we get information about people who escaped or
- 19 those who were captured. We would hear information about them that they are still
- 20 alive.
- 21 Q. [10:26:41] How did you receive this information?
- 22 A. [10:26:51] This information usually come over the radio. But also, most times,
- 23 if you are not an officer you are not allowed to listen to the radio. Mostly it is the
- 24 commanders who listen.
- 25 Q. [10:27:15] Just to be -- make sure we're clear. When you say "radio", what type

- 1 of radio do you refer to?
- 2 A. [10:27:30] These are usually the small hand-held radios.
- 3 Q. [10:27:54] Do you know -- did you listen to these radio broadcasts?
- 4 A. [10:28:18] Sometimes in the evening, when you are seated close to where the
- 5 commanders are, yes, you can listen.
- 6 Q. [10:28:38] Did these radio broadcasts have a specific name?
- 7 A. [10:28:52] Mostly people listened to it from Mega.
- 8 Q. [10:29:12] What would Joseph Kony say about these radio broadcasts?
- 9 A. [10:29:25] He says all those are not true. Those are rumours. There is no one
- 10 who returns home and is alive. That could be just a recorded voice.
- 11 Q. [10:29:54] Before you escaped the LRA did you believe what Joseph Kony was
- 12 saying?
- 13 A. [10:30:14] Some of the things that Joseph Kony says, like, for instance, the
- 14 recording of voices, sometimes we thought it was true because we even didn't know
- 15 that people were living at home. So we would believe that what he was saying was
- 16 true.
- 17 Q. [10:30:53] Ms Witness, can you briefly describe the personality of Joseph Kony.
- 18 A. [10:31:13] Based on my, my personal knowledge of him, Kony is a human being,
- 19 a normal human being.
- 20 Q. [10:31:31] Now, we talked last Friday about prayers.
- 21 PRESIDING JUDGE SCHMITT: [10:31:35] No, perhaps let -- let me.
- When you say he is a normal human being, could you perhaps, if you can, elaborate
- 23 a little bit on that. What do you mean by that?
- 24 THE WITNESS: [10:31:56] (Interpretation) There are some people who say that Kony

25 becomes other things, transforms into other things. (Redacted)

- 1 (Redacted) I have never seen Kony
- 2 convert into anything else other than a human being.
- 3 The only thing that happens is that sometimes he predicts events, and maybe that's
- 4 why people make the assumption that he has the capability of transforming into
- 5 something other than a natural human being. But when he predicts things, those
- 6 things do come to pass.
- 7 PRESIDING JUDGE SCHMITT: [10:32:40] Perhaps you can dwell into the
- 8 predictions more then, in light of this answer.
- 9 MR OBHOF: [10:32:48] It will take care of questions that I had in 15 minutes, so I can
- 10 do it now.
- 11 PRESIDING JUDGE SCHMITT: [10:32:52] Why not? You know, when it fits now,
- 12 because this is the benefit of hearings, there is always -- it's always nice if you have
- a little bit of spontaneity in it.
- 14 MR OBHOF: [10:33:07]
- 15 Q. [10:33:07] Now, you're discussing these predictions, what type of predictions
- 16 would Joseph Kony make?
- 17 A. [10:33:26] The predictions that came to pass were actually quite a lot. Because,
- 18 when we were there, during battle he would tell us things. For example, when we
- 19 were going to Sudan, he told us -- he collected people together when we were in
- 20 Sudan and told us that there is going to be a battle. He said most of his commanders,
- 21 his high-ranking commanders would switch sides, and when they switch sides they
- 22 would come back and fight against him, they would capture people, and take them
- 23 back home. A lot of people denied. They said they were not going to do this, they
- 24 are not going to leave the LRA, they are not going to switch sides. And he told them,
- 25 he said, "You guys are actually denying for nothing, because I know that most of you

- 1 guys are going to switch over and go home. Some of you, the lucky ones, will
- 2 actually go back home and see where they are from, and some of you will not actually
- 3 see where you are from." And this actually happened.
- 4 Q. [10:34:59] Now from the passages, these are predictions related to escape.
- 5 Would Joseph Kony make predictions about anything else?
- 6 A. [10:35:25] Yes, there are other predictions.
- 7 For example, when we were there, if there is an illness, he would say, okay, let me go
- 8 and collect some -- a specific herb. He would go, dig up some herbs, mix them up
- 9 and give them to somebody to take. And these herbs would actually heal that
- 10 person. If somebody does not have that kind of power, they would not go
- 11 somewhere, dig up random herbs, give them to somebody and use them to heal that
- 12 person.
- 13 Q. [10:36:06] Do you know where Joseph Kony received the knowledge about these
- 14 herbs?
- 15 A. [10:36:26] It's very difficult for me to actually determine, or say exactly where he
- 16 gets this kind of information from, but, when I went there, I found that he already
- 17 had these powers, he was already able to get this information. But he told me that
- 18 this started when he was home. He said that when he was at home, this thing took
- 19 him to the Odek hills, and it was while he was at the Odek hills that this thing started
- 20 showing him all these different herbs and medications and other things. That's how
- 21 he explained it to me.
- 22 Q. [10:37:18] Is there anything significant about these Odek hills?
- A. [10:37:32] Well, to him, perhaps, the Odek hills are significant, because he says
- 24 that when he goes to the Odek hills he is able to collect a lot of things. And even
- 25 though he is not able to get them at the Odek hills, if he goes and prays at the hills,

- then he is directed from the Odek hills to where he can find these other specific
- 2 things.
- 3 Q. [10:38:07] Now one additional question about the predictions. When he would
- 4 predict these escapes, would he ever identify by name which person would escape?
- 5 A. [10:38:35] Most times he would not identify specific names, but he would
- 6 mention it or talk about it generally. There are some people who actually tell -- he
- 7 would actually tell some people that "you, I know you are not going to stay here."
- 8 But whoever he tells that the person is not going to stay, the person would deny it.
- 9 But then eventually they would escape.
- 10 Q. [10:39:06] Now these specific persons, do you happen to remember any of the
- 11 specific person's names?
- 12 A. [10:39:22] Yes. I do recall on a specific day they were sitting and just having
- 13 a discussion. And he said, "Well, I am going to, to talk about this." He was
- 14 referring to Kijura, some commander known as Kijura. He said, "Kijura is not going
- 15 to stay here. If Kijura does not escape, he is not going to live, because Kijura does
- 16 not intend to stay. He is not happy and he wants to leave. But, if he decides to
- escape, then he is going to die along the way."
- 18 Q. [10:40:15] And what happened to this Kijura?
- 19 A. [10:40:27] We later heard that Kijura died in battle.
- 20 Q. [10:40:32] Do you know the other name of Kijura?
- 21 A. [10:40:41] No, I do not know.
- 22 Q. [10:40:46] Do you know if Kijura had any wives?
- 23 A. [10:40:55] Yes, he did have wives.
- Q. [10:41:24] Now, you mentioned about Joseph not transforming into anything.
- 25 But during his prayers what was his demeanour, his temperament like?

- 1 A. [10:41:53] It's difficult to read somebody's mind. So sometimes someone will
- 2 sit next to you, the person would laugh with you, but it's very difficult to detect -- or,
- 3 to determine what is in their mind or what exactly they are thinking.
- 4 Q. [10:42:19] And when Joseph was talking -- when the spirits were talking to
- 5 Joseph, did his demeanour or his body language or his temperament change at all?
- 6 A. [10:42:45] Most times, when Kony speaks to people, addresses people, what I
- 7 observe is that when he starts preaching, even when people are tired, people are
- 8 seated and tired, he doesn't tire, he doesn't wear out, he can start addressing people in
- 9 the morning and keep on going the whole day until evening. He does not get tired.
- 10 But I did not see any specific changes or anything happening, except that he would
- 11 talk nonstop.
- 12 Q. [10:43:31] Now, you mentioned your beliefs about Kony last week, about
- 13 whether you believed he would be talking to spirits. From what you witnessed and
- 14 heard from others, did the people, other people in the LRA, did they believe?
- 15 A. [10:44:04] Based on my observation, yes, there are some people who did believe,
- 16 because whatever he said or whatever he predicted would come to pass. So even if
- 17 you did not want to believe it or you had your doubts, you would probably believe,
- 18 because when he predicts or says something, it actually happens.
- 19 Q. [10:44:30] Now from what you saw and heard, how did this spiritual, this
- 20 possession, this spiritual part of the LRA, how did it affect women?
- 21 A. [10:44:56] I didn't quite understand your question.
- 22 PRESIDING JUDGE SCHMITT: [10:45:00] It's very general. I think the witness
- 23 would not be able to talk for all the women in the LRA. Mainly she can talk, of
- course, about her sentiments and her feelings and her experiences, and perhaps, if she

25 has talked to other women, which would have given her some information in that

- 1 regard. But it's a little bit too general, the question, I would say, Mr Obhof.
- 2 MR OBHOF: [10:45:29] I can go back to the question in the last five minutes of this
- 3 session and use a private session to discuss that.
- 4 Q. [10:45:39] Now, without going into a lot of detail, do you remember any of the
- 5 names of the spirits which spoke to Joseph Kony?
- 6 A. [10:45:58] Yes, I do recall some of the spirits, the spirits that spoke to Kony.
- 7 MR OBHOF: [10:46:23] And, your Honour --
- 8 PRESIDING JUDGE SCHMITT: [10:46:25] I think, Ms Witness, please go on. Please
- 9 tell us the spirits that you recall.
- 10 THE WITNESS: [10:46:38] (Interpretation) The spirits that I recall; Who Are You,
- 11 Silindi, and Silva, and Juma.
- 12 MR OBHOF: [10:47:02]
- 13 Q. [10:47:03] Now specifically to Silindi, what was Silindi's job?
- 14 A. [10:47:16] Silindi would usually pray, and Silindi was the women's spirit.
- 15 Q. [10:47:29] And when you say "the women's spirit," what would Silindi do for the
- 16 women?
- 17 A. [10:47:43] Silindi would protect women. For example, if there is a pregnant
- 18 woman, Silindi would advise the person to pray. Silindi would ask them to put
- 19 a black stone or a black rock. And if there is a battle or if there is a war, then Silindi
- 20 would choose to be close to the women, praying with the women.
- 21 MR OBHOF: [10:48:29] Now, your Honour, I would like to go to page 0125 of her
- statement and just ask one, one small area.
- 23 PRESIDING JUDGE SCHMITT: [10:48:39] That's okay. Yes.
- 24 MR OBHOF: [10:48:40]
- 25 Q. [10:48:40] Which spirit would tell Joseph to abduct and not to abduct women?

- 1 A. [10:48:57] Silindi would mostly instruct Joseph Kony on the abduction of
- 2 women.
- 3 Q. [10:49:15] Now, Ms Witness, you mentioned about shea oil last week, twice. Is
- 4 there any significance to shea oil in the LRA?
- 5 A. [10:49:34] Shea oil is extremely important. Shea oil, camouflage, water and
- 6 rocks were extremely important in the LRA and were used frequently.
- 7 Q. [10:49:54] And you mentioned water just now. Do you know -- do you
- 8 understand why water was important?
- 9 A. [10:50:11] Yes, I do. The reason why they would say water was important was
- 10 because water was one of the first creations of God. And water is used to dispel -- or,
- is used to cleanse people of all evil or bad things.
- 12 Q. [10:50:38] Now finally, you mentioned rocks. What are the significance of
- 13 rocks to the LRA?
- 14 A. [10:50:54] Rocks were important to the LRA because, when they started at the
- outset, the LRA started fighting with rocks. So whenever you came -- somebody
- came to the LRA as an officer you are given a rock, and this rock is supposed to be
- 17 kept on your person.
- 18 Q. [10:51:39] How did people keep these rocks on their person?
- 19 A. [10:51:55] I do not know how each and every individual did that, but, for
- 20 example, myself -- if it's the officers, the officers would put it in a bag and you would
- 21 always keep that bag close to you. There were two types of stones. There was one
- stone that you would tie around your wrist, or on your arm. But the officers had
- 23 bigger ones, and those they kept in bags.
- Q. [10:52:36] Just for the certainty, is there a difference between rocks with the

25 word "got" and rocks with the word "kidi"?

- 1 A. [10:52:58] Yes, there is a difference, because the rocks that we use is a white rock.
- 2 And in the LRA it's referred to as the stone bomb, it's a white rock. And the one that
- 3 people keep on their person is also a white rock, but it's a smaller version of that rock.
- 4 Q. [10:53:37] Now, Ms Witness, we have talked a lot about spiritualism and spirits,
- 5 are there any holidays in the LRA, or any sacred days?
- 6 A. [10:53:57] Yes, there were sacred days in the LRA, and that day is dedicated to
- 7 Who Are You.
- 8 It's also very difficult to keep that day sacred, because, for example, if you are
- 9 attacked on that day, then you have to fight. So that day is usually dedicated to
- 10 fighting.
- 11 Q. [10:54:27] And which day is that?
- 12 A. [10:54:41] That is the seventh of -- I have forgotten the month, but I know it is on
- 13 the seventh day.
- 14 MR OBHOF: [10:55:01] If I may put a date to her from her statement (Overlapping
- 15 speakers)
- 16 PRESIDING JUDGE SCHMITT: [10:55:05] No problem.
- 17 MR OBHOF: [10:55:07]
- 18 Q. [10:55:07] Does April 7th sound correct, Ms Witness?
- 19 A. [10:55:16] Yes, that's correct.
- 20 Q. [10:55:35] Now, we have talked about the predictions, the spirits speaking
- 21 through Joseph, some of the rituals, and the medicines. Was there anything else that
- 22 Joseph Kony did by virtue of the spirits possessing him?
- 23 A. [10:56:09] Other than prayers, on occasion, if there is going to be an intense
- 24 battle, they would fight and he would make a sacrifice, he would sacrifice a lamb or
- a sheep and burn that. And he would also immerse people into water.

- 1 Perhaps if the spirit came in the presence of everybody, perhaps it would scare us all

- 6 Joseph Kony. I want you to -- I want to turn to the issue of Kony and his

- 9 A. [12:04:18] Based on my observation, sometimes it's the spirit that actually gives
- 10 promotions. Because during some battles, it's the spirit that instructs the soldiers to
- 11 go to a particular defence and overrun that defence. So if the spirit selects
- 12 a particular commander to go to that defence, that defence is successful, then the
- 13 spirit will be -- that commander will be promoted. That means that it's not Kony
- 14 who has promoted that commander, but, rather, the spirit who has promoted that
- 15 commander.
- 16 Q. [12:04:59] And last but not least, in your observations, were there commanders
- 17 that were liked or preferred by spirits?
- 18 A. [12:05:25] Based on my observation, I did not see the spirit differentiate between
- 19 any of the commanders. But, sometimes the spirit would direct that a certain
- 20 commander would lead a particular mission. For example, when people were going
- 21 to Soroti, the spirit chose Tabuley to be the overall commander of that mission. I do
- 22 not know whether it was because the spirit favoured Tabuley, but based on my
- 23 knowledge, I know that the spirit did not differentiate between its commanders.
