- 7 asking you questions about an organisation called ADVERMA.

- 9 any victims of events in Timbuktu of 2012 to 2013?
- 10 THE INTERPRETER: [9:53:34] Message from the Songhai booth: The Songhai booth

- 16 Q. [9:54:34] Mr Witness, you said on Friday that's at transcript T-138, French
- 17 realtime, at page 94, lines 7 to 11 when I asked you what was the work of
- ADVERMA, you responded: (Interpretation) "ADVERMA is a group of people, an
- 19 association."
- 20 (Speaks English) Who were members of this group of ADVERMA? Who were
- 21 members of ADVERMA?
- 22 A. [9:55:09] What I remember at this time is that there was Fodé, Wang, (indistinct).
- 23 There also was al-Jum'at Ag Aghaly, Al Housseyni Ag Al Journat.
- 24 Q. [9:56:35] You -- you stated that ADVERMA would take information from people.
- 25 Did ADVERMA take any information from victims of the events in Timbuktu of 2012

- 12 not be permitted to conduct further investigations throughout the trial. Now, the
- 13 Prosecution has met this witness twice in preparation sessions, and we are concerned
- 14 that now that he's on the stand, they are now eliciting further information and details
- 15 that are not in his statement.
- Now, given the particular nature as well, this is obviously highly prejudicial. And
- 17 there's key issues of prejudice and notice if the Prosecution is given a free reign to
- elicit through anonymous hearsay this type of detail.
- 19 PRESIDING JUDGE MINDUA: [10:24:49](Interpretation)
- 20 Madam Prosecutor, what's your answer?
- 21 MS LUPING: [10:24:51] Very briefly, Mr President, your Honours.
- 22 First of all, as your Honours are very aware, you do have the ability clearly to freely
- 23 assess and admit evidence under Article 69(3) and (4) and Rule 63 of the Rules of
- 24 Procedure. Secondly, there is no issue of lack of notice. And I would refer to

- 3 already we -- myself, it really broke my heart. And as for the children who were
- 4 there, they shouldn't even have seen such things, an adult being struck and parts of
- 5 her bodies popped out. Children shouldn't have had to see that. It really disgusted
- 6 everyone. And it really affected us.
- 7 It affected us a great deal.
- 8 Q. [12:03:10] Thank you very much, Mr Witness.
- 9 This question leads me to asking for additional -- more specific information. So I
- 10 would like to ask for more information about the other categories of victims, if the
- 11 Chamber grants leave.
- 12 PRESIDING JUDGE MINDUA: [12:03:34](Interpretation) Go ahead, Mr Kassongo.
- 13 MR KASSONGO: [12:03:38](Interpretation)
- 14 Q. [12:03:38] Mr Witness, could you tell us in your own words what you heard or
- saw about the return of this woman who had been flogged to her family or, in the
- case if there had been multiple women flogged, how did these women go back to
- 17 their families?
- 18 A. [12:05:15] In actual fact, it really affected them. It really did them harm. Even
- 19 their parents had a hard time seeing it. Others left the city because they didn't want
- 20 to have to carry that shame. So some actually, out-and-out left the city.
- 21 Q. [12:05:46] Thank you very much, Mr Witness, for that additional information.
- 22 One final question to conclude, just one minor thing.
- Now given this suffering and the impact of this suffering on the population, in
- 24 general terms, could you tell us whether the -- whether the inhabitants of Timbuktu
- 25 continued to go to their mausoleums.

- 1 That's my final question, and I thank the Chamber.
- 2 A. [12:06:59] Now people go there. Thank God.
- 3 Q. [12:07:09] Thank you very much, Mr Witness, for all that information. On

- 5 MR KASSONGO: [12:07:25](Interpretation) We thank the Chamber as well for their
- 6 patience.
- 7 Your Honours, the Legal Representatives of Victims have concluded.
- 8 PRESIDING JUDGE MINDUA: [12:07:32](Interpretation) Thank you. Thank you
- 9 very much for your questions. And you kept your word. You were not long.
- 10 I now turn to the witness, first of all.
- 11 Mr Witness, the Defence will now begin cross-examination. So please be patient and
- show goodwill as you have done with the Office of the Prosecution.
- 13 Ms Taylor, please go ahead.
- 14 QUESTIONED BY MS TAYLOR:

- 7 MS TAYLOR: [12:12:48] Mr President, we may need to go into private session.
- 8 PRESIDING JUDGE MINDUA: [12:12:56](Interpretation) Courtroom officer, if you
- 9 could.
- 10 (Private session at 12.12 p.m.)
- 11 THE COURT OFFICER: [12:13:02] We are in private session.

- 17 MS TAYLOR: [12:21:19]
- 18 Q. [12:21:19] Now, Mr Witness, did the rebellion create any tensions in Timbuktu
- 19 as concerns individuals who were suspected to be -- to be associated with the rebels?
- 20 A. [12:22:22] It just so happened that I was still very young at that time, so I really
- 21 can't say much. But after when -- when Alph- -- president -- at the time of Alpha
- 22 Oumar Konaré, the president, I remember there was the flame of peace. There was
- 23 social cohesion. People got along.
- 24 In other words, there was peace.
- 25 Q. [12:22:56] Mr Witness, when did you yourself arrive in Timbuktu?

- 5 A. [12:23:47] Well, I didn't hear about that. What's more, I really didn't pay any
- 6 attention to that kind of information.
- 7 Q. [12:24:37] Now, Mr Witness, turning to 2012, did you hear or learn of anything
- 8 concerning an Arab group called the FLNA? That is, the Front de libération nationale
- 9 de l'Azawad.
- 10 A. [12:25:20] Yes. We heard about that. The group was in existence. We did
- 11 hear about it.
- 12 Q. [12:25:35] And do you know an Arab individual called Mohamed Lamine Ould
- 13 Sidatt?
- 14 A. [12:26:17] It was just the other day that we learned that he had died. I did
- 15 know the name, and we learned that he had been a mayor.
- 16 Q. [12:26:37] Was this individual, Mohamed Lamine Ould Sidatt, the secretary
- 17 general of the FNLA?
- 18 A. [12:27:17] I don't know anything about the FNLA, and I don't know anything
- 19 about that association. I know that it does exist. I've heard of it. I know the name,
- 20 but other than that, I don't know anything about that organisation.
- 21 Q. [12:27:35] Mr Witness, you've said you've heard of it.
- 22 Did you hear of it in April 2012 in Timbuktu?
- 23 A. [12:28:17] Yes. Everyone says it like that. Everyone saw -- even as they went
- by in their vehicles, we would see FLNA (sic) written on their vehicles. And at one
- 25 point, they were working with the Malian authorities. That was before the crisis.

- 1 Q. [12:28:43] Mr Witness, at transcript 137, edited, page 9 to 10, lines 22 to 1, you
- 2 said:
- 3 "There were groups -- there was one group that was set up by the authorities. It was
- 4 a militia."
- 5 Mr Witness, this militia that you referred to, was this an Arab militia?
- 6 A. [12:30:03] They were Arab groups. It was -- they were different to the FLNA
- 7 (sic), but they spoke the same language. So you couldn't distinguish them -- you
- 8 couldn't tell one from the other, but they were the ones who knew. They knew
- 9 which group was which group. They knew which militia was which militia.
- 10 Q. [12:30:35] Now, Mr Witness, speaking specifically of this Arab group, are these
- also referred to as the Berabiche Arabs?
- 12 A. [12:31:21] Yes. They had a lot of names. They were called by a lot of names.
- 13 I don't know too much about it, but these Arabs were called by lots of different
- 14 names.
- 15 Q. [12:31:37] And in this first month, in April 2012, did this Arab group take any
- weapons and cars from the military camp?
- 17 A. [12:32:12] Yes, of course. They took them, and they took a lot of materials from
- 18 offices as well. Everybody knew that.
- 19 Q. [12:32:27] You've said that they took a lot of materials from offices.
- 20 Did they also take a lot of materials from private buildings?
- 21 A. [12:32:56] Just for the authorities at the start.
- 22 Q. [12:33:08] Mr Witness, can you explain what you mean by that. You said:
- 23 (Interpretation) "Good. It's just for the authorities at the start."
- 24 A. [12:33:51] What I was saying, at the start when the town was taken, it was just
- 25 where the authorities were. Those places were affected. The materials, the vehicles,

- 2 Q. [12:34:23] Now, Mr Witness, I'd like to turn to a group called the "MNLA."

- 5 think that's what it was because people who speak about the independence of
- 6 Azawad, they attack public buildings and offices and departments. These are
- 7 people -- these aren't the people who want to occupy Azawad.

- 9 all if it's somewhere you want to keep. If you have to occupy the place,
- 10 you're -- you're going to take it without harming it.
- 11 Q. [12:36:41] Mr Witness, is it correct, based on what you yourself heard, that not
- 12 everyone in Timbuktu supported the idea of separation, that is, for Azawad to
- 13 become a separate state?
- 14 A. [12:37:02] Yes. It's true. There were people from Timbuktu who didn't agree
- 15 with these people. When it came to taking a decision, there was the population.
- 16 You had to get the viewpoint of the population. But some people had their intention
- to do that, but they didn't consult. They didn't ask anybody's point of view. They
- 18 did that with their own initiative.
- 19 PRESIDING JUDGE MINDUA: [12:38:27](Interpretation)
- 20 Madam Prosecutor.
- 21 MS LUPING: [12:38:28] Mr President, it's not a objection but a request for greater
- 22 clarity by asking what time period we're talking about. There is nothing here about
- 23 any time period from the question. It was a very general question with no specific
- 24 time period. We can't -- we don't know whether it relates to the temporal period of
- 25 the charges, before or after.

- 1 There's just no context for it without a time period included.
- 2 PRESIDING JUDGE MINDUA: [12:38:59](Interpretation) Ms Taylor.
- 3 MS TAYLOR: [12:39:01] Thank you, Mr President.
- 4 I had actually put a time period earlier when we started speaking about the Arab
- 5 groups. I can put a time period, but I do have follow-up questions to this witness.
- 6 PRESIDING JUDGE MINDUA: [12:39:20](Interpretation) Please, if you could
- 7 specify the time frame.
- 8 MS TAYLOR: [12:39:22]
- 9 Q. [12:39:22] Now, Mr Witness, I'm speaking specifically about the beginning of
- 10 April in 2012.
- 11 Did you hear anything about the MNLA committing exactions in Timbuktu?
- 12 A. [12:40:32] In 2012, I don't remember exactly. But according to what people said,
- there were a lot of atrocities that were committed. A lot of things were destroyed.
- 14 People spoke about it a lot. I don't remember exactly.
- 15 Q. [12:40:51] Mr Witness, we can turn to your statement. It's OTP tab 1,
- 16 MLA- -- MLI-OTP-0072-0143. At page 0150, paragraph 32.
- 17 And if that could be displayed for the interpreters.
- 18 I'll read it out.
- 19 THE COURT OFFICER: [12:41:25](Interpretation) Would counsel kindly confirm
- 20 which redacted version should be displayed. Thank you.
- 21 MS TAYLOR: [12:41:34] R-04.
- 22 Q. [12:42:07] Mr Witness, I'll read it out for you. This is in a section concerning
- 23 the arrival of the armed groups in Timbuktu. And it states, in your declaration:
- 24 (Interpretation) "The Arab militia was first of all attached to the government army.
- 25 It took advantage of the retreat from Timbuktu to pillage weapons and vehicles found

- 1 at the military camp of public property and private property such as project vehicles,
- 2 banks. Satar, who was one of the leaders of this militia at the time, was assassinated
- 3 the year before in Koiratao when he was playing cards. The MNLA, who say that

- 5 day towards 11 o'clock. The men from the militia then had rumours circulating
- 6 saying that the MNLA was committing atrocities in the town. And still on the same
- 7 day, the Islamists arrived in their turn towards the early evening. They entered the
- 8 town crying, 'Allah Akbar! Allahou Akbar!'"
- 9 (Speaks English) Mr Witness, do you recall giving this information to the Prosecution?
- 10 (Overlapping speakers)
- 11 A. [12:45:42] Yes.
- 12 Q. [12:45:44] And, Mr Witness, do you recall giving this information to the
- 13 Prosecution?
- 14 A. [12:46:06] Yes.
- 15 Q. [12:46:07] Now, Mr Witness, I'm just going to read a sentence from this.
- 16 (Interpretation) "The men in the militia allowed rumours to circulate saying that the
- 17 MNLA was committing atrocities in the town."
- 18 Can you explain what you meant by that.
- 19 A. [12:46:59] People said what was happening. That's it. People said what was
- 20 happening, if something was happening in town, they would say it. But it was
- 21 a long time ago now. But people were saying what was happening. It was later
- 22 that we discovered what was happening.
- 23 Q. [12:47:26] Now, Mr Witness, this was said -- talking about rumours that the
- 24 MNLA was committing atrocities, what type of atrocities were being described in
- 25 these rumours?

- 1 PRESIDING JUDGE MINDUA: [12:48:34](Interpretation)
- 2 Madam Prosecutor.
- 3 MS LUPING: [12:48:36] Mr President, it's just a question of interpretation actually
- 4 from French into English. I note that the passage from the statement, the word used
- 5 is "des exactions", but in English it's being interpreted as "atrocities", which is
- 6 a different meaning. And I -- I note -- I note that the Defence counsel's using the
- 7 word from the English transcript, but I would just ask that the correct translation be
- 8 given so that when it's put back to the witness, he has the correct word from his actual
- 9 statement.
- 10 PRESIDING JUDGE MINDUA: [12:49:22](Interpretation)
- 11 Madam Prosecutor, you are speaking about paragraph 32 of the statement; is that
- 12 correct?
- 13 MS LUPING: [12:49:29] Correct, in French, because it's a French
- statement -- sorry -- a statement in French. The word that was used by the witness
- 15 was "des exactions".
- Now, the Defence counsel has repeated the word instead as "atrocities" --
- 17 PRESIDING JUDGE MINDUA: [12:49:44](Interpretation) Indeed.
- 18 MS LUPING: [12:49:46] -- because that was the interpretation, I believe, being given
- 19 by the interpreter. But I would ask that the witness instead be -- that the word be
- 20 used is relating to exactions, "exactions", and not atrocities, because that is
- 21 a misinterpretation of the word from the statement.
- 22 PRESIDING JUDGE MINDUA: [12:50:12](Interpretation) Yes, Ms Taylor, in the
- 23 paragraph 32, it uses the word "the MNLA were committing exactions."
- 24 THE INTERPRETER: [12:50:28] Which can also be translated as abuses, says the
- 25 interpreter.

- 1 MS TAYLOR: [12:50:33] Mr President, I'm not sure if you just heard the interpreters.
- 2 They just said that "exactions" can also be translated as "abuses". So that's what the

- 5 believe there's a substantive difference here. I read out "exactions" to start with.
- 6 I've used "exactions" twice. I believe that the witness -- his answer that he just gave
- 7 should be allowed to be read into the record, as the witness did answer.
- 8 And as a native English speaker, there is not a significant difference between
- 9 exactions and abuses. So I don't believe it's worth wasting time on this issue.
- 10 PRESIDING JUDGE MINDUA: [12:51:24](Interpretation) Very well. I'm not an
- 11 Anglophone. I'm a Francophone. But I think that "abuses" is "exactions", but it's
- 12 not "atrocities" in French. That's all.
- 13 Very well. So I think we are all in agreement. Let's continue. Ms Taylor.
- 14 MS TAYLOR: [12:51:43] If -- if the interpreters could please interpret what the
- 15 witness said.
- 16 PRESIDING JUDGE MINDUA: [12:52:06](No interpretation)
- 17 THE INTERPRETER: [12:52:10] Message from the Songhai booth: Could the witness
- 18 go back over his answer.
- 19 PRESIDING JUDGE MINDUA: [12:52:19](Interpretation) Very well.
- Witness.
- 21 THE WITNESS: [12:52:29](Interpretation) I said that I don't remember exactly the
- 22 date. But a lot of things happened, but I don't remember the exact dates.
- 23 MS TAYLOR:
- 24 Q. [12:52:55] Thank you, Mr Witness. I wasn't asking for the specific date. I was
- 25 referring to the fact that in your statement you referred to the -- I'll read it out exactly

- 2 (Interpretation) "The militia had rumours circulated that the MNLA was committing
- 3 exactions in the town."
- 4 (Speaks English) What type of exactions did you hear of in these rumours?
- 5 A. [12:54:15] Well, I remember the case of a man whose name is Moussa. It was
- 6 said that he raped women and he killed people. So when the Islamists came, they
- 7 came and arrested him and ...
- 8 THE INTERPRETER: [12:54:54] Neither the English interpreter nor the French
- 9 transcript fully understood the last sentence pronounced by the interpreter.
- 10 MS TAYLOR: [12:55:04] Could the Songhai interpreter please repeat the last
- sentence. It seems that the English and French interpreters did not hear it.
- 12 THE SONGHAI INTERPRETER: [12:55:16](Interpretation) Yes. They shot at the
- 13 best cattle that people had.
- 14 MS TAYLOR: [12:55:32]
- 15 Q. [12:55:33] Now, Mr Witness, at transcript 138, page 20, you described
- 16 a conversation with Abdoul Djalil, the French Islamist. And when you testified
- about this conversation at transcript 138, page 20, lines 3 to 7, you said:
- 18 "The first exchanges I had with Abdoul Djalil, that was on a Sunday. When he came
- 19 with his wife, he [...] had heard that the MNLA was raping people and doing that.
- 20 [...] but he" had -- "he said he had seen nothing of that."
- 21 The Prosecution then showed your statement, which was written six years after this
- 22 conversation, which had the word "Islamists".
- 23 Mr Witness, when you described this conversation with Abdoul Djalil about these
- rumours, did you intend to refer to the rumours concerning the MNLA?
- 25 A. [12:57:37] What am I meant to attribute to him?

- 1 MS TAYLOR: [12:57:43] Was my full question interpreted to the witness? I didn't
- 2 hear it being interpreted.
- 3 THE COURT OFFICER: [12:57:58] Your Honours, there was a brief loss of
- 4 connection. Perhaps counsel could repeat the question. Thank you.
- 5 MS TAYLOR: [12:58:07] Thank you. Just a message to the Songhai interpreters.
- 6 To make this easier, I'm going to read out a first part of the question and break for
- 7 you to interpret it and then continue. But if the witness could be instructed not to
- 8 respond until I have finished.
- 9 Q. [12:58:54] Now, Mr Witness, at transcript 138, page 20, lines 3 to 7, you stated:
- 10 "The first exchanges I had with Abdoul Djalil, that was on a Sunday. When he came
- with his wife, he said he had heard that the MNLA was raping people and doing that.
- 12 And he -- but he said he had seen nothing of that."
- 13 If that could be interpreted.
- Now, after this, the Prosecution showed you your statement, which was written six
- 15 years after this conversation with Abdoul Djalil, which had the word "Islamists".
- 16 My question, Mr Witness, is, when you described this conversation to the
- 17 investigators, did you mix up the MNLA and the Islamists? Did you mean to refer
- 18 to the rumours that concerned the MNLA at this time?
- 19 A. [13:01:12] Yes, I made a mistake. Of course, it was the Islamists. It was the
- 20 Islamists, because Auld (phon) told me that it was the Islamists because, ultimately,
- 21 he joined in with them.
- 22 THE INTERPRETER: [13:01:31] Abdoul Djal (phon) was the name mentioned in this
- 23 response. Abdoul Djilal -- Djalil.
- 24 MS TAYLOR:
- 25 Q. [13:01:42] So, Mr Witness, you are saying that Abdoul Djalil arrived on the first

- day in Timbuktu, and he told you he heard on this first day in Timbuktu of rumours
- 2 concerning the Islamists committing sexual violence? The Islamists, not the MNLA.
- 3 THE INTERPRETER: [13:02:42] Message from the Songhai interpreter: We cannot
- 4 hear what the witness has said.
- 5 MS TAYLOR:
- 6 Q. [13:02:49] Mr Witness, can you repeat what you just said.
- 7 A. [13:03:10] Yes. I was saying, is, that was what Abdoul Djalil was telling me.
- 8 That's what he told me at that time.
- 9 Q. [13:03:21] Now, at page 35 of the same transcript, that's transcript 138, lines 24 to
- 10 25, you said, this conversation happened on "The same day that the country fell.
- 11 Nobody knew who was who."
- Now, when Abdoul Djalil spoke to you, did he at this point know the different
- 13 groups and the difference between them?
- 14 PRESIDING JUDGE MINDUA: [13:03:54](Interpretation) Miss Prosecutor.
- 15 MS LUPING: [13:03:56] Objection, Mr President. Could I ask that the sound be cut
- off to the witness.
- 17 PRESIDING JUDGE MINDUA: [13:04:07](Interpretation) Courtroom officer, if you
- 18 could.
- 19 THE COURT OFFICER: [13:04:09] Your Honours, the sound has been cut off.
- 20 PRESIDING JUDGE MINDUA: [13:04:13](Interpretation) Thank you very much.
- 21 Madam Prosecutor.
- 22 MS LUPING: [13:04:17] Mr President, I'm objecting to the way this question is being
- 23 put to this witness. The question was: Now, when Abdoul Djalil spoke to you, did
- 24 he at this point know the different groups and the difference between them?
- Now, with all due respect, your Honours, this witness is being asked to speculate as

- to what Abdoul Djalil did or did not know at that time. He's not in a position to
- 2 know what was in the mind of some other person regarding what he knew. This is a
- 3 entirely inappropriate question.

- 5 MS TAYLOR: [13:04:56] Mr President, I think the words "entirely inappropriate" are
- 6 quite an exaggeration here. I can reformulate, but he is describing a conversation. I
- 7 can ask him whether, on the basis of this conversation, it would appear to him that he
- 8 understood the different groups or that he was aware of the different groups.
- 9 PRESIDING JUDGE MINDUA: [13:05:20](Interpretation) That wording seems to be
- more appropriate to me.
- 11 So there you have it.
- 12 Courtroom officer, if you could.
- 13 THE COURT OFFICER: [13:05:36] Your Honours, the sound has been re-established.
- 14 PRESIDING JUDGE MINDUA: [13:05:41](Interpretation) Thank you very much.
- 15 Ms Taylor.
- 16 MS TAYLOR:
- 17 Q. [13:05:45] Now, Mr Witness, going back to this conversation, did Abdoul Djalil
- indicate whether he knew of the MNLA or the FNLA or the Berabiche militia?
- 19 A. [13:06:25] No, he didn't say that to me.
- 20 PRESIDING JUDGE MINDUA: [13:06:28](Interpretation)
- 21 Madam Prosecutor.
- 22 MS LUPING: [13:06:31] Mr President, the witness has now answered, but I was
- 23 going to object because it was a compound question and rather confusing. But the
- 24 witness has responded, and we will leave it at that.
- 25 PRESIDING JUDGE MINDUA: [13:06:47](Interpretation) Very well.

- 4 join Ansar Dine after this conversation took place?
- 5 A. [13:07:41] No, it was later. It was later on. That is when he joined that group.
- 6 It was later. One fine day, he came to see me, and in ... He came by, and it was at
- 7 a later time.
- 8 Q. [13:08:04] Now, speaking of this first period after the Malian authorities
- 9 withdrew, based on what you saw or heard, did any bandits or locals take advantage
- of the situation to settle scores?
- 11 A. [13:09:13] The people of Timbuktu who wanted to get back -- I haven't
- 12 understood. How? I haven't understood.
- 13 Q. [13:09:44] It might be a matter of language.
- 14 After the Malian authorities left, did any of the locals take advantage to settle
- 15 accounts, to régler des comptes personnels ou faire du mal aux autres?
- 16 PRESIDING JUDGE MINDUA: [13:10:38](Interpretation) Interpretation?
- 17 THE INTERPRETER: [13:10:42] Message from the Songhai interpreter: We lost the
- 18 connection momentarily.
- 19 THE COURT OFFICER: [13:11:05] Your Honours, the connection is re-established.
- 20 PRESIDING JUDGE MINDUA: [13:11:10](Interpretation) Ms Taylor, the witness
- 21 may not have understood the question. There is no answer so far.
- 22 MS TAYLOR: [13:11:21] Yes, I'll repeat the question. I just wanted to make sure we
- 23 had a connection.
- Q. [13:11:26] My question, Mr Witness, speaking of these first couple of days in
- 25 April, did any of the locals take advantage of the situation to (Interpretation) "settle

- 19 paragraph 48. I can hear words being mentioned that are appearing in paragraph 49.
- 20 So I -- I'm not certain that the interpreter is actually reading out the correct paragraph
- 21 to the witness.
- 22 MS TAYLOR: [14:50:56] We thank the Prosecutor for pointing that out. And if we
- 23 could have clarification as to which paragraph was read to the witness. And if the

- 20 Q. [15:01:07] Did he take steps to help the local population?
- 21 A. [15:01:40] Yes. The people were -- trusted him. And when he -- when they
- 22 left, he asked them -- he sorted things immediately.
- 23 Q. [15:01:59] Did he make vehicles available to the locals to use?
- 24 A. [15:02:38] Yes. Everyone who was able to get close to him to explain things to
- 25 him, he was able to sort out what they needed.

- 14 Q. [15:21:45] And is it correct that it was the Arab who was told to pay the money
- 15 he owed to the Tamasheq noir?
- 16 A. [15:22:30] When -- yes. When they came, they said that the money had to be
- 17 paid. And that was a problem that existed in the time of Mali and that actually
- everything that confirmed the time of Mali, they -- they weren't considered -- they
- 19 weren't concerned with.
- 20 But -- but from that time, he should have the electricity put back because they were
- 21 going to take this on themselves. They were going to be responsible for the
- 22 electricity.
- 23 Q. [15:23:16] I'm just going to show a video, Mr Witness. It's Defence tab 37. It's
- 24 MLI-OTP-0012-1813. It's a video dated 15 December 2012. And we'll play it
- 25 without sound. And we'll stop at 1:08.

- 7 to the witness, and it's necessary for me to play a video with this date for this reason.
- 8 And I do ask that we be allowed to put questions to the witness without premature
- 9 objections.
- 10 Now, the Prosecutor, I believe, has itself not followed a specifically clear line of
- 11 questioning with this witness when it comes to the BMS. So I don't believe that I
- should be using words such as "Hesbah" when they're not the words that are being
- used by the witness himself.
- 14 So I would ask that we don't have any objections when I haven't even put a question.
- 15 I haven't asked him to identify the building. I have a very specific question.
- 16 PRESIDING JUDGE MINDUA: [15:29:30](Interpretation)
- 17 Madam Prosecutor.
- 18 MS LUPING: [15:29:31] Mr President, if I look at page 70 at lines 17 to 18 -- and this
- is the way it's certainly been translated also for the witness.
- 20 (Interpretation) "Mr Witness, do you know where this place is?" (Speaks English)
- 21 The witness responded:
- 22 (Interpretation) "Yes, it's the Islamic police."
- 23 (Speaks English)(Overlapping speakers) My concern is simply that just simply stating
- 24 the date of the video may not be sufficient for this witness. He's asked to look at the
- 25 video. And knowing this footage and being familiar with who filmed it, this is at the

- 1 time of the *Hesbah*. This witness has actually made reference to the *Hesbah*
- 2 occupying the BMS and that the police moved to the *Gouvernorat*. He has explicitly

- 4 In fairness to this witness, I do believe he needs to be informed that this is at the time
- 5 of the *Hesbah*.
- 6 A date is not sufficient for this witness. It will be too confusing for him.
- 7 MS TAYLOR: [15:30:43] Mr President, if I may?
- 8 PRESIDING JUDGE MINDUA: [15:30:50](Interpretation) Court officer, did you cut
- 9 the link to the witness?
- 10 THE COURT OFFICER: [15:30:56] It's still cut off.
- 11 PRESIDING JUDGE MINDUA: [15:31:00](Interpretation) Very well. Ms Taylor.
- 12 MS TAYLOR: [15:31:02] Mr President, my line of questioning, if I had been allowed
- 13 to pursue it, specifically concerns the writing underneath that window. I was
- intending to ask the witness if he's aware when that writing was put there. Now,
- 15 that line of questioning I should be allowed to pursue. I didn't ask the witness who
- 16 was occupying the building at this time. He was the one that described it as the
- 17 police Islamic. Now I really do ask that I be allowed to put this line of questioning to
- 18 the witness without any premature objections which appear to be of testimonial
- 19 nature.
- 20 PRESIDING JUDGE MINDUA: [15:31:53](Interpretation) Ms Taylor, you can't turn
- 21 down all the objections.
- 22 Madam Prosecutor, I think this is a bit premature this time. Let Ms Taylor put her
- 23 question again.
- 24 Ms Taylor.
- 25 MS TAYLOR: [15:32:10] Mr President, if the sound could be established for the

- 15 A. [15:33:57] No. No, I don't know.
- 16 Q. [15:34:17] Mr Witness, as I mentioned, this video is dated December 2012. Do
- 17 you know if this writing was on the wall for the time when the Islamists were in the
- 18 building?
- 19 A. [15:35:12](No interpretation) (Overlapping speakers)
- 20 PRESIDING JUDGE MINDUA: [15:35:14](Interpretation)
- 21 Madam Prosecutor.
- 22 MS LUPING: [15:35:16] Mr President, perhaps if I could ask that the sound be cut
- off to the witness.
- 24 PRESIDING JUDGE MINDUA: [15:35:25](Interpretation) Courtroom officer, please
- cut the sound.

- 1 THE COURT OFFICER: [15:35:31] Your Honours, the sound has been cut off.
- 2 PRESIDING JUDGE MINDUA: [15:35:36](Interpretation) Thank you very much.

- 4 MS LUPING: [15:35:39] Three quick points, Mr President.
- 5 First, what we see on the screen has P-O-L-I-C. I believe that, first of all, it's
- 6 a question of -- I mean, it possibly is "police", but we can't actually see fully what is
- 7 actually written there. And on this point, we would say that the Defence is actually
- 8 testifying on the point. That's the first point.
- 9 The second point is, he was asked explicitly by Defence counsel if he knows when it
- 10 was written on the wall. And he stated very clearly, "No. Non, je ne sais pas."
- 11 (Interpretation) "No, I don't know."
- 12 (Speaks English) (Overlapping speakers) He was asked that question, and he clearly
- 13 said he doesn't know.
- 14 Now we are having a second question, and the question is:
- 15 "Do you know if this was written during the period that the Islamists were in the
- 16 building?"
- 17 I mean, it's -- it has been asked. It was answered. Now we have a question which
- is extremely unclear, because we know that there was more than one group within
- 19 the building. We had the police, we've had *Hesbah* -- the witness has testified to that.
- 20 So now this is not only asked and answered, but it's also an extremely unclear and
- 21 unfair question for the witness.
- 22 PRESIDING JUDGE MINDUA: [15:37:02](Interpretation) Ms Taylor, I'm somewhat
- 23 doubtful about the question you're putting to the witness about this exhibit. I have
- 24 the document here from the Victims and Witnesses Section that says that the witness
- does not know how to read very well. So he doesn't even know what's written on

- the wall, and then you're asking him questions about various series of dates. I'm not
- 2 so sure he'll be able to reply.

- Now, as the Prosecution may recall, a video was shown with P-55, which dates from
- 12 June 2013 where you can clearly see P-O-L-I-C-E. So it's not in dispute that it was
- 13 there. The question is the witness's powers of observation.
- 14 And I do believe that I didn't actually ask the same question twice. It wasn't
- 15 interpreted correctly in the French. The second question was whether it was there
- 16 for the time -- the entire time that the Islamists were there. I wasn't asking when it
- 17 was put there for a second time.
- 18 Now, the witness has answered. I believe we can move on. I was actually about to
- 19 move on when the Prosecution objected. So we lose a lot of time for objections that
- are not relevant because I was actually moving on.
- 21 PRESIDING JUDGE MINDUA: [15:39:15](Interpretation)
- 22 Madam Prosecutor, Ms Taylor would like to move on to something else. What
- 23 would you like to add?
- 24 MS LUPING: [15:39:24] If -- if Defence counsel is moving to a wholly different
- 25 question and is not going to seek to have the interpretation of an answer that we

- believe is unfairly put -- put on the record, then we would indeed have no further

- 25 Mr Witness, did Hamed Moussa work for the police at the BMS?

- 6 A. [15:43:04] Blue. And there was writing on the vests in both Arabic and French.
- 7 Q. [15:43:16] Did anyone tell you what the writing meant?
- 8 A. [15:43:51] That's what everyone said, that it -- it was written "police". That's
- 9 "police" in French and in Arabic. That's what people said.
- 10 Q. [15:44:07] Mr Witness, is it correct that you don't know what the word "Hesbah"
- 11 means?
- 12 A. [15:44:32] No, I don't. That's how it was written, but I didn't ask.
- 13 Q. [15:44:42] Mr Witness, was it difficult for you to distinguish between the
- 14 different Islamists and the different sections they worked for?
- 15 A. [15:45:16] We don't know, but everyone called them the "Islamists". And that's
- 16 all.
- 17 Q. [15:45:26] Now, speaking still of Hamed Moussa or Mohamed Moussa did
- 18 you hear originally or initially -- that is, at the beginning of the events, that he was
- 19 with the MNLA?
- 20 A. [15:46:29] Yes. Basically it was one of his colleagues who had said that the
- 21 soldier -- the Malian soldiers had slit their throats. If they saw them, they would slit
- 22 their throats. And afterwards, he went into Ansar Dine.
- 23 Q. [15:47:01] Now, Mr Witness, did you hear or learn that Hamed Moussa had
- 24 wanted the Islamists to leave Timbuktu?
- 25 A. [15:47:44] Yes, at the beginning when they came and there was all those things.

- 2 Q. [15:47:58] Now, speaking of the beginning, did you hear or learn that Hamad

- 6 said about the soldiers and the Islamists. That is what he had said. And at the end,
- 7 he -- he joined their group, and the other one went to look.
- 8 Q. [15:49:35] Mr Witness, in the transcript, French, we have:
- 9 (Interpretation) And the other one went to look.
- 10 (Speaks English) Is that what you said, or did you refer to a name?
- 11 A. [15:50:16] Yes. Well, I didn't give a person's name. The person who told this
- story ... It's the person who told the story. It's him, and he is the one who didn't
- want to tell it, in fact, when he joined the others.
- 14 Q. [15:50:41] What is the name of this person who told the story?
- 15 MS TAYLOR: [15:51:01] Mr President, if we can go into private session.
- 16 PRESIDING JUDGE MINDUA: [15:51:07](Interpretation) Courtroom officer.
